BEGINNING OF THE SCHOOL YEAR

All students grades K-3 assessed with a <u>State Board approved interim reading assessment</u> to determine Significant Reading Deficiency. (C.R.S. 22-7-1205)

Grades 1-3: within 30 calendar days of enrollment. (C.R.S. 22-7-1205 (1)(a))

Kindergarten: during first 90 calendar days of school year. If administered within first 60 calendar days of school year, not required to administer literacy component of the school readiness assessment. (C.R.S. 22-7-1205(1)(a.5))

Reading skills are at or above grade level expectations:	Monitor student progress. Grade Level Reading Competency: Districts may consider applying the grade level reading competency criteria (Interim Cut-Off Scores for Grade Level Competency).
