- Direct enrollment for children with IEPs begins: Late February/early March
- Direct enrollment for general education students opens:

2024/25 process for AUs and IEP placement

Scenario 1 - Direct Upload Path

Step 1: AU (or designee) creates spreadsheet of IEP students (including program ID and contact info) to send to CDEC

Step 2: AU (or designee) uploads list to CDEC

Step 3: CDEC combines AU lists / datasets

Step 4: CDEC uploads combined list monthly to BridgeCare

Step 5: BridgeCare system generates prepopulated family application

Step 6: Family is provided with a link to their specific application

Step 7: Family completes the application

Scenario 2 - Manual Application Initiated by AU through Admin Portal

Step 1: AU (or designee) enters the application portal

Step 2: AU (or designee) creates application for family

Step 3: Family application is available in the BridgeCare system

Step 4: Family is provided with a link to their specific application

Step 5: Family completes the application

Scenario 3 - Family-Initiated Application

Step 1: Family enters the application portal

Step 2: Family attest to IEP

Step 3: Family advised to reach out to their AU

Step 4: Manual application initiated by AU (or designee)

Reducing administrative work for children with IEPs

- 1. Allowing families to use a specific link to have program options default to the preferred program
- 2. Not running families you attest to an IEP through the matching algorithm



Lower likelihood of children having to move due to gen ed seat being taken by a special ed seat or vice versa

Ease of making changes

Reviewing Placements

AUs can review a secure report in the Universal Preschool Application Portal that shows the selections for all families in their catchment area where the family self-identified that their student has an IEP.

AUs can access this report at any time directly in the application portal.

Making Changes to Placements

CDEC has implemented a process to make AUs the final decision-maker on these placement determinations consistent with the IEP. The AU may request a different placement from what the family originally indicated in the application portal that aligns best with the IEP. The AU should work directly with families regarding changes.





Listening session insights

Areas that received positive affirmation

- Reserved IEP seats
- Not running children with IEPs through matching algorithm
- Batch upload process more closely reflects existing workflows and workload

Process pain points we're still exploring

- Difficult to help families when an AU doesn't know what communication they have received
- Some AUs requested doing batch uploads shortly before Spring Break
- AUs noted additional workload to support the process

Communication and training needs

- AUs and Child Find need tools and training to educate families
- Families need direct training
- Need clear distinctions between "enrollment" and "eligibility"

Enabling ongoing 2023/24 enrollment alongside 2024/25 applications and enrollment

Building logic around the four family paths (pre-registration, matching path, IEP path)

Enhancing provider profiles to make program language requirements clearer to families

Discovery work in progress

- 3-year-old processes
 - Differentiating between 3-year olds with IEPs and 3-year-olds with historical allotment
- Income verification process
- Enhanced language and accessibility
 - Determining translation languages
 - Accommodations associated with the Colorado Law for Persons with Disabilities
