**[Informational] Accountability Data Release Schedule** (see updated accountability timeline at end of this communication)

CDE is on track to release accountability-related data files and reports throughout the month of August and early September. Below is our best prediction on release dates. We will be in contact if anything shifts. As a reminder, the data files shared with authorized district level Accountability Contacts are embargoed until their public release - you may share data with personnel as needed. The Individual Student Growth Reports (ISRs) may be downloaded and shared with families right away. This embargo process provides your neighboring districts with time to understand their own data. Thanks for your cooperation.

<p><b>Preliminary Framework Reports.</b> PDF reports of the preliminary School and District Performance Frameworks are scheduled for release through Syncplicity to authorized Accountability Contacts in late August. <p><b>Data Dashboards through Online UIP.</b> UIP data dashboard updates are scheduled for August with the release of growth data. This information is accessed by logging into the <a href="#">UIP/ACI online system</a>. To access the dashboard through the online UIP, go to the “Priorities and Targets” tab. ## **[Possible Action] Assigning District Accountability Contacts**

To gain access to accountability-related data files (including student level personally identifiable information - PII), each district superintendent must assign an Accountability Contact. Accountability Contacts for the district are assigned using the Identity Management (IdM) system. Local Access Managers (LAMs) assign the Accountability Contact role to the superintendent or the superintendent's designees who will be responsible for:

- Receiving performance framework results and related data, including student Personally Identifiable Information (PII) via Syncplicity
- Submitting the Accreditation Form
- Receiving accountability related communications

## **[Possible Action] Recruitment for the 2025-26 Accountability Work Group (AWG)**

While the AWG has been in operation for many years, the recent Accountability Bill ([H.B. 25-1278](#)) formalized the group as a state advisory group. This included requiring specific roles (e.g., superintendents, school and district administrators, statewide organizations, parents) and naming the Commissioner of Education as the appointer. Please help us recruit strong membership as we prepare to implement the new provisions of the accountability work over the next few years. More information is available [here](#). ## **[Informational] Additional Accountability Reminders**

**Accreditation Form (required for all districts):** All districts must review and verify the district rating and school plan types using the *Accreditation Form* (in the Accreditation Portal within [the UIP/ACI online system](#)) by **September 26**. The form will be available to district accountability contacts once frameworks are released to districts. Your user role must be designated as "Accountability Contact" to access the form, as described in [this guide](#). For additional support, fill out the [assistance request form](#) using your district's information or email [accountability@cde.state.co.us](mailto:accountability@cde.state.co.us).

**Request to Reconsider:** Additional details on the 2025 request to reconsider process for schools and districts is posted on the [request to reconsider website](#). The request to reconsider process will begin upon the release of preliminary frameworks. Final request to reconsider materials are due **October 15**.

**2025 UIP Plan Submission:** Improvement plans are due for public posting on **October 15** unless the district is eligible for submission flexibility (e.g., biennial, combined, January). The UIP will be populated with school and district specific information (submission deadlines, requirements) with the public release of rating information. All users of the online template will have access and use the new streamlined version beginning in the 2025-26 school year. Most sites are already using this template, but this will be new for some sites. [This document](#) provides an overview on the changes to the template including using assurances, synthesizing the data presentation, and strategically clarifying terminology.

### **[Informational] Release of School-Level Learning Environment District Profile Reports this Fall**

In the May Accountability Contact communication, we mentioned that the [district profile reports](#) (i.e., a public dashboard that CDE manages involving measures related to the learning environment, including chronic absenteeism, student discipline and behavior, school climate survey information, and mental health professional ratios) will be provided to district staff at the school-level this fall. The profile reports will be shared via Syncplicity, using the same access for designated accountability contacts. The reports will include data for each school in the district using the data that was submitted to CDE. The school level reports will not be posted publicly and are intended to support school and district planning.
