KIPP Colorado Schools is a charter management organization that currently operates five schools in Denver Public Schools with a sixth school opening in the 2018-19 school year. KIPP Colorado Schools has demonstrated success with underserved students in a number of ways over the last 15 years, including significantly high academic growth and high overall school ratings (Performance). KIPP Colorado Schools states that they are "committed to serving educationally underserved communities in Denver County, Adams County, and other Front Range communities." The application provides clear information regarding their educational model, strategies for community engagement and processes for opening up new schools and partnering productively with school districts.
