Acronym	Name	Definition/Additional Information
AC	Administrative Consideration	Change in testing environment conditions
AF	Accessibility Feature	CBT-embedded and TA-provided features that allow for inclusive, accessible, and fair testing for diverse populations of students. AFs are available to all students. Students determine when and how to utilize AFs throughout the testing experience
AO	Additional Order	Placed in PearsonAccess <sup>next</sup> to receive additional assessment or administration materials
BOCES	Board of Cooperative Educational Services	Organizations that provide shared educational programs and services to school districts
CAS	Colorado Academic Standards	Expectations of what students need to know and be able to do at the end of each grade in the content areas of reading, writing, math, science, social studies, etc.
CBT	Computer-based Test	Assessment taken on a computer or tablet device (including iPads and Chromebooks)
CDE	Colorado Department of Education	
CMAS	Colorado Measures of Academic Success	State assessment for the content areas of science, social studies, math, and ELA including CSLA
CoAlt	Colorado Alternate	Alternate state assessment for the content areas of ELA, math, science, and social studies for students with a significant cognitive impairment
CORA	Colorado Open Records Act	Anyone can request information that is in the possession of a government office
CPR	Colorado Practice Resource	CMAS sample item sets (computer-based and paper-based), scoring guides, and rubrics.
CSLA	Colorado Spanish Language Arts	Accommodated version of the ELA assessments for eligible English learner students in grades 3 and 4
DAC	District Assessment Coordinator	The superintendent-appointed individual at the district level responsible for the overall coordination of state assessment administration.
DLM	Dynamic Learning Maps	CoAlt math and ELA assessments for students with significant cognitive impairment
DOB	Date of Birth	Birthdate of the student
DRC	Data Recognition Corporation	Company that provides the online platform for the ACCESS assessment
DTC	District Technology Coordinator	The individual at the district who ensures that site readiness activities, designed to ensure that testing environments are ready for testing, are completed in advance of testing.
EBSR	Evidence Based Selected Response	Multi-part selected response ELA assessment item type
EEO	Extended Evidence Outcome	Extension of the Colorado Academic Standards, measured on the alternate assessment
EL or ELL	English learner or English language learner	
ELA	English Language Arts/Literacy	Combined assessment of reading and writing
ELP	English Language Proficiency Level	See NEP, LEP, FEP, etc. for examples
FEP	Fluent English Proficient	Students will be monitored for two years (monitor 1 is year one)
ISR	Individual Student Report	Test results in a printed or printable PDF report for an individual student - also SPR
LEA	Local Education Agency	The school district or BOCES
LEP	Limited English Proficient	
LEP	Local Education Provider	A district, school, or program
MVS	Modification Verification Submission	
NAEP	National Assessment of Educational Progress	National assessment administered to schools on a sampling basis
NEP	Non English Proficient	Newcomer students with little or no academic English
PAN or PANext	PearsonAccess <sup>next</sup>	Assessment management system for all CMAS content areas and CoAlt science and social studies (accessed online)

PBT	Paper-based Test	Assessment taken on paper
PCR	Prose Constructed Response	Extended response writing item type on ELA/CSLA assessment
PII	Personally Identifiable Information	Sensitive student data (e.g., name, SASID, DOB, etc.) that can only be sent through a secure file transfer system
PLD	Performance Level Descriptors	Description of student performance at various command levels of the content area (four levels for S/SS, five levels for math/ELA including CSLA)
Pre-ID		A process or file that sends student registration information to the vendor and creates online registrations or student ID labels to apply to test materials
PSAT		SAT-aligned assessment for 9th and 10th graders created by CollegeBoard
S/SS	Science and Social Studies	Also Sci/SS
SAC	School Assessment Coordinator	The individual at the school level responsible for the overall coordination of state assessments administration. May also see this as STC - School Test Coordinator
SASID	State Assigned Student Identifier	Assigned via the Record Integration Tracking (RITs) system, unique for each student, and is always 10 digits
SAT		College Entrance Exam created by CollegeBoard - 11th graders take this assessment
SBD	Student Biographical Data	Opportunity within CDE's Data Pipeline system for districts to review student biographical data and make changes to ensure accuracy for reporting
SPR	Student Performance Report	Test results in a printed or printable PDF report for an individual student - also ISR
SR/PNP	Student Registration/Personal Needs Profile	The file or user interface fields used to register students for CMAS assessments, indicate student demographic information, and assign accessibility features and accommodations
STT	Speech-to-Text	Student speaks into an assistive technology device to respond to assessment questions
SWD	Student with a Disability	Student with an IEP or 504 plan
TA	Test Administrator	An individual at the school ultimately responsible for administering CMAS assessments (not a student teacher)
TAM	Test Administrator Manual	Manual that provides directions on the security and administration of the various assessments
TE	Test Examiner	Licensed education professional who administers the alternate assessment
TEI	Technology Enhanced Item	Type of test item that presents questions and captures student responses in ways other than written responses or multiple choice
TIR	Testing Irregularity Report	Form used to report irregularities, misadministrations, or security breaches experienced during assessment administration
TTS	Text-to-Speech	Audio feature embedded in the CBT testing platform that reads passages, items, and answer options to students. This auditory presentation of the assessment replaces the need for an adult reading from an oral script. TTS must be pre-assigned through PANext and based on individual student need. TTS is an AF for math, science, and social studies; it is a modification for ELA which requires CDE verification prior to assignment and use.
UAR	Unique Accommodations Request	Request to use an accommodation available to a very limited number of students who meet specific criteria. Submit via Syncplicity by December 15 for unique accommodations identified in the Procedures Manual.
UI	User Interface	Screens in PearsonAccessnext that logged in users access to complete assessment tasks
