ITEM TYPE: Action Item

BACKGROUND:

We will start at 8:30AM on Day One and 8:45 on Days Two and Three with overviews and general housekeeping.

Grant reviews will begin at 9:00AM each day.

The CCAB intends to conclude the meeting by Wednesday afternoon. If necessary, the meeting may run longer. If we experience overruns on time or difficulties with technology, we will move the announcement of the final prioritized list and official motions on approvals by the CCAB to a later date.

Funding Availability for FY24 *Pending Governor's Signature:

• Cash Grants: \$110,000,000

• Supplemental Grants: \$49,705,220

<u>Senate Bill 23-220</u> allocates \$49,705,220 for the purpose of funding supplemental grants related solely to cost overruns caused by COVID-19 pandemic related inflationary pressures and supply chain disruptions. Any remaining funds will be applied to a second round of supplemental grants to be awarded no later than August 17, 2023. Any remaining funds after the second round will be applied to projects awarded but not funded due to prioritization and funding availability in the regular FY24 grant cycle.

*The CCAB will vote to solidify a grant review process for the second round of supplemental grants on Wednesday afternoon, at the end of this meeting.

Individual Grant Application Review:

- 1) When a grant is up for review, the Director will call on the grant applicant to present.
- 2) The Director will introduce the project (applicant name & project title), then ask the presenters to introduce themselves.
- 3) The presenters will be given a two-minute window to present to the CCAB:
 - The presentation should include any items the applicant wishes to highlight or address pertaining to the proposed project. No visual materials will be allowed for the presentation.
- 4) Following the applicant's presentation, the Board Chair will open the floor to CCAB discussion.
- 5) After all questions have been answered, each CCAB member will complete scoring for the application.
- 6) The CCAB will then vote on moving the project to the recommendation shortlist.
 - NOTE: Moving an application to a funding recommendation shortlist does not guarantee the application will be awarded. See below for the shortlist prioritization procedure.
 - If a project that has a waiver is not voted to the shortlist, the waiver will not be reviewed.
- 7) If an application is voted to the shortlist and a waiver is requested as part of the application package, the CCAB will evaluate the waiver, ask any questions, and complete a waiver evaluation sheet.
 - NOTE: Statutory Limit waivers (to prevent exceeding maximum available bonding capacity) are required by statute. There will not be a review or vote.
 - The Board Chair will entertain a motion to approve each waiver.
 - An applicant whose waiver request is denied is still eligible to receive a grant.
- 8) This process will be repeated until all applications have been reviewed.
- Upon completion of all application reviews, including finalizing scores and a ranking of scored projects by each CCAB member to break ties, Division staff will complete the recommended shortlist.

NOTE: Two-minute presentation and having a representative(s) present is optional. The applicant will not be penalized for the absence of either.

Review of Prioritized Grant Applications:

After all reviews are complete, scores and ranks will be compiled by staff and two lists will be presented to the CCAB with the funding recommendation prioritized shortlist (Cash Grants and the first round of Supplemental Grants). Both lists will be sorted by their identified statutory

prioritization and by their normalized average rank among voting CCAB members, with any ties broken by average evaluation score. In the event of any remaining ties in scoring, the CCAB will break the tie with a vote.

The CCAB will review each list separately, make any final remarks, and then make their final motion to approve the list. The prioritized lists may include backup projects to be awarded in the event a higher-ranked project fails to secure matching funds or other funding becomes available.

- Per to SB23-220, Supplemental Grants do not require further review or approval.
- Pursuant to C.R.S. 22-43-7.109(7)(a), The prioritized list of traditional Cash Grant projects will be submitted to the State Board of Education (SBE) for approval.
- The SBE may approve, disapprove, or modify the provision of financial assistance for any project recommended by the CCAB if they conclude that the CCAB misapplied the prioritization criteria defined in statute.

The abovementioned is only intended to be a general outline of the process. The CCAB's recommendations will be made in accordance with applicable statutes and rules.

BACKGROUND:

Senate Bill 23-220 allocates \$49,705,220 for the purpose of funding supplemental grants related solely to cost overruns caused by COVID-19 pandemic related inflationary pressures and supply chain disruptions. The bill creates two grant rounds for Fiscal Year 2024. Round One is available for those six supplemental grant requests submitted through the regular FY24 grant cycle. Any remaining funds will be applied to a second round of supplemental grants to be awarded no later than August 17, 2023. Any remaining funds after the second round will be applied to projects awarded but not funded due to prioritization and funding availability in the regular FY24 grant cycle.

The draft bill was discussed at the April board meeting. An email was sent to all eligible applicants, sharing a presentation on bill status and staff recommendations on process. That presentation is attached for review and consideration.

A grant program for school renovations and new construction funded through local matching dollars, the Colorado State Land Board, the Colorado Lottery, and excise taxes.







FY24 Building Excellent Schools Today Grants - SB23-220

FY24 requests \$522 million

- 54 grants requesting \$518 million from BEST with a project total of \$758 million.
 - Six supplemental requests for \$34 million due to inflation.
 - 15 projects requesting over \$10 million each, totaling about \$428 million.
 - 8 charter school applications for \$40 million.

FY24 (Traditional) \$110 million

\$160 million originally available for cash grants based on estimated revenues.

- -\$30 million (eliminated SB21-207 transfer to the Assistance Fund, with no indication of transferring in the future).
- +\$4.7 million from Air Quality Improvement Grants (not fully awarded).
- +\$15 million from the State Education Fund.
- +\$10 million from revenues earned on public school lands dedicated to the Permanent Fund.

FY24 (Supplementals) \$49,705,220

*Two Rounds. Any remaining funds will be awarded to traditional grants that fall below the funding line (in prioritized order).





Round 1: \$49,705,220

Criteria:

Project is a current FY24 Supplemental Grant request.

Considerations:

- CCAB will review, score and prioritize all FY24 BEST Grant applications as normal. Staff will separate supplemental requests and create two prioritized lists at the end of the third day.
- There will still be a vote to "shortlist" or award all projects.
- Waivers will be considered separately from the "shortlist" vote.

Round 2: \$15,452,217.30 (assuming full awards from Round 1)

Criteria:

- Grantees awarded in the 2021 or 2022 Fiscal Year Cycle (does not include emergency grants).
- Current grant agreements. Have not been closed out as of the application date (June 15, 2023).
- Related solely to cost overruns in projects caused by COVID-19 Pandemic-related inflationary pressures and supply change disruptions.
- To preserve the integrity of the project goals as initially approved without expansion of initial project scope.
 - Provide documentation from grant application or add alternate list showing scope was considered at some point. BEST does not pay to demo scope that was already installed.

Considerations:

- Approximate a traditional grant round.
- Application submittal may be reduced (dependent on staff capacity). Focus on Supplemental Criteria.
- CCAB will review, score and prioritize, vote to "shortlist", and considered waivers separately.





Round 2 Timeline (approximate):

- May 17, 2023 CCAB will hold a special meeting to finalize timelines and requirements.
- June 1, 2023 Application portal opens.
- *June 15, 2023 Applications due.
- June 15 July 20, Review and creation of summary packets. Distributed to CCAB as soon as possible.
- July 20, 2023 Regularly scheduled meeting of the CCAB. Further discussion if necessary.
- August 7 (week of) CCAB will review and finalize prioritized list. *no later than August 17, 2023.

Considerations:

- Email to all eligible applicants with summary and Grant Manager Registration Form.
- Staff will work as quickly as possible to get approved grant agreements delivered, via DocuSign.
 - You are always at your own risk before a grant agreement is approved.
 - We cannot reimburse for work completed before an agreement is in place.
- Awarded projects will receive a new Supplemental Grant Agreement. Process will be to close out original grant and then open supplemental grant.
