## Executive Summary

---

In 2008, the General Assembly of the State of Colorado enacted the Building Excellent Schools Today Act, known as “BEST,” in order to repair or replace Colorado’s most needy public school facilities. The Colorado Department of Education’s Division of Capital Construction manages BEST — a competitive grant program available to all public school districts, charter schools, institute charter schools, boards of cooperative educational services and the Colorado School for the Deaf and Blind.

Applications are reviewed on a yearly cycle and recommended for funding by the Capital Construction Assistance Board (CCAB)—a nine-member appointed board that, in conjunction with staff, reviews grant applications for the current fiscal year. The Division has eight in-house assessors working to complete condition assessments and adequacy surveys for every facility in the state by 2022, and to reassess every five years thereafter to help the CCAB make informed decisions.

BEST is funded through multiple revenue sources: State Land Board proceeds, marijuana excise tax, Colorado Lottery spillover funds, and interest accrued in the Public School Capital Construction Assistance Fund. Matching funds are required by statute and calculated based on a series of factors, from the district’s bond election efforts over the past 10 years to the district’s assessed value per pupil.

This BEST Annual Report is submitted to the General Assembly pursuant to Section 22-43-7-111, C.R.S.

This project addresses health and safety by replacing failing steam condensing boilers and fan coils with a new condensing boiler and chiller system with associated fan coils and piping to serve the affected areas. The existing 64-year-old system has failed, resulting in space heater usage for supplemental heat, and unsafe conditions with steam ruptures having occurred within the school. This project will enhance student achievement by providing a safe and thermally controlled environment for students.

This project is recommended for BEST Cash funding as follows:

Grant Amount - \$304,770.95; District Contribution - \$249,358.05 or 45%, with the source of match coming from the district's general fund.

##### **Peyton 23JT/ Career Technical Educational Facility (CTEF) Roof Replacement**

This project addresses health and safety by replacing a roof that is currently leaking and no longer under warranty. This project will enhance student achievement by eliminating concerns when it rains or snows that the roof will leak. When there is a water event the students are relocated from their classrooms or school activity. The district then is required to eliminate the water, repair interior damage and confirm that no mold has grown. The proposed roof system will be designed for 20-year life expectancy and have a three-year construction warranty.

This project is recommended for BEST Cash funding as follows:

Grant Amount - \$205,598.80; District Contribution - \$168,217.20 or 45%, with the source of match coming from the district's general fund and an approved Mill Levy Override for capital repairs.

##### **Walsh Re-1/ ES and HS Safety and Security Upgrades**

This project addresses health and safety by replacing a leaking gas line, addressing the insufficient power to the kitchen, and replacing hardware that no longer provides for secure access to the elementary school and the high school.

This project is recommended for BEST Cash funding as follows:

Grant Amount - \$279,085.40; District Contribution - \$228,342.60 or 45%, with the source of match coming from the district's general fund.





### **Burlington RE-6J / District-Wide HVAC & Electrical Renovation**

This project addresses health, safety, and technology by replacing failing HVAC and electrical systems at three schools. The existing mechanical and electrical systems and controls at the elementary, middle, and high school are all failing, at end of life, and inadequate to provide effective climate control and reliable power to classrooms. Existing indoor air quality is poor due to little or no ventilation, with high carbon dioxide concentrations in most classrooms, and radon above acceptable levels in the middle school. This project will enhance student achievement by replacing these systems and enabling significantly improved air quality and thermal comfort in classrooms, as well as greater electrical capacity and distribution for technology needs. Work will exceed code required ventilation, and systems were selected to optimize efficiency, life cycle cost, and occupant health.

This project is recommended for BEST Cash funding as follows:

Grant Amount - \$4,756,391.19; District Contribution - \$4,217,931.81 or 47%, with the source of match coming from a secured Qualified Zone Academy Bond

### **Buffalo RE-4J / HS Water Mitigation**

This project addresses health and safety by resolving an existing issue with a regularly flooding basement due to groundwater intrusion, which has led to standing water, water damage, and mold growth, as well as threatened electrical circuits in the basement area. This project will enhance student achievement by eliminating the water intrusion and moisture issues through essentially raising the basement floor and extending the sump pit above the groundwater level, relocating electrical connections, and adding ventilation, thereby preventing potential interruption in instruction due to additional damage from flooding.

This project is recommended for BEST Cash funding as follows:

Grant Amount - \$369,682.53; District Contribution - \$30,017.47 or 8%, with the source of match coming from the district's general fund.

### **Durango 9-R / District-wide Entry Lock Replacement**

This project addresses health and safety by replacing failed and obsolete Schlage CM993 door locks at 10 district schools. The door locks are beyond their useful life and have been discontinued for several years. Replacement parts for the failing locks are no longer available. This project will enhance student achievement by securing these 10 school facilities with new Schlage AD400 radio-controlled locks. These new locks will be linked into the district's current security system which is already set up with the capability to manage the controllers.

This project is recommended for BEST Cash funding as follows:

Grant Amount - \$82,401.18; District Contribution - \$201,740.82 or 71%, with the source of match coming from the district's Capital Renewal fund.

### **Frontier Academy / ES Flood Mitigation**

This project addresses health and safety by resolving an existing issue with an elementary school prone to flooding in severe rain events due to poor site drainage. This project will enhance student achievement by eliminating the water intrusion and moisture damage issues through regrading and diverting storm water to two existing drainage paths on the site, thereby preventing potential interruption in instruction due to additional flooding and prolonging the life of the building.

This project is recommended for BEST Cash funding as follows:



Grant Amount - \$57,232.98; Charter School Contribution - \$52,830.44 or 48%, with the source of match coming from the school's general fund.

#### **Buena Vista R-31 / BVHS/MS Renovation & Replacement**

This project addresses health and safety by replacing the main Buena Vista High School/Middle School and by renovating the high school athletic facility. A majority of the main facility systems are past their life expectancy and have failed. Plumbing systems require destructive demolition to access, the roof structure is at or beyond capacity to hold replacement systems, and a lack of proper site drainage has impacted the viability of the structure. Security systems are inadequate as well. This project will enhance student achievement by correcting site drainage and replacing the main facility on the same campus; it will include the renovation of the high school athletic facility to upgrade systems and connect to the new building. The new facility will be built in phases so as not to disturb or displace students during construction. The project will be designed to achieve the highest performance certification possible through LEED (Gold) or CHPS (Verified Leader).

This project is recommended for BEST Lease Purchase funding as follows:

Grant Amount - \$21,362,125.68; District Contribution - \$29,500,078.32 or 58%, with the source of match coming from the district's bond election which passed in 2017.

#### **Steamboat Springs RE-2 / ES, MS, and HS Roofing Replacement**

This project addresses health and safety replacing three leaking and aged roofs. A roof consultant has verified the need to replace these roofs and prepared construction documents that include additional insulation, improved drainage, and new edging and detailing. This project will enhance student achievement by restoring the building's enclosure and eliminating the distraction caused by water leaks and on-going repairs. The district plans to engage a roof contractor for on-going inspections and maintenance to provide the new roofs with a prolonged service life.

This project is recommended for BEST Cash funding as follows:

Grant Amount - \$537,491.34; District Contribution - \$2,448,571.66 or 79%, with the source of match coming from the district's 2017 bond proceeds fund.

#### **Poudre R-1 / MS and HS Dust Collection Systems**

This project addresses health, safety, and technology by replacing or repairing dust collection systems in 14 wood shop classrooms. This project will enhance student achievement by eliminating the significant dust being released into the classrooms dirtying the air and obscuring vision creating an un-safe environment. Also, some of the current systems are so loud that students and teachers cannot hear each other; another safety issue.

This project is recommended for BEST Cash funding as follows:

Grant Amount - \$130,885.12; District Contribution - \$278,130.88 or 68%, with the source of match coming from the district's career and technical education funds.

#### **Limon Re-4J / K-12 Partial Roof Replacement**

This project addresses health and safety by replacing a leaking roof on the existing gym. The low-slope metal roof over the newly refinished gym floor is leaking due to aged, failed seams. The leaks endanger the wood floor, and create a hazardous slick surface during activities, as well as water damage to other nearby surfaces. This project will enhance student achievement by over-framing the roof with an EPDM roof, preventing further



damage to the gym. The new roof is anticipated to carry a 10-year warranty, with a life expectancy of 20-25 years.

This project is recommended for BEST Cash funding as follows:

Grant - \$212,774.16; District Contribution - \$160,513.84 or 43%, with the source of match coming from the district's capital reserve fund.

#### **South Routt School District RE-3 / HS South Roof Replacement**

This project addresses health and safety by replacing the aged and deteriorated roof on Soroco High School. The existing roof is leaking and causing damage to the building. Current roof is beyond repair due to multiple layers, leaks are saturating the underlayment, and water is ponding on the roof causing live load concerns. This project will enhance student achievement by eliminating the distraction of leaking roofs and on-going maintenance efforts. New roof will have additional insulation and a 20-year warranty.

This project is recommended for BEST Cash funding as follows:

Grant Amount - \$378,289.98; District Contribution - \$241,857.53 or 39%, with the source of match coming from the district's general fund.

#### **Canon City Re-1 / Washington ES Replacement**

This project addresses health and safety by replacing the elementary school. The facility has numerous system deficiencies which require replacement. The structure of the facility is failing due to an overloaded roof. Glass block tiles have cracked and begun to fail, and lintels and steel channel mullions are overstressed. This project will enhance student achievement by building a new facility which will meet the needs of a 21<sup>st</sup> Century learning environment. The facility will be built on the northeast corner of the campus and will not disrupt or displace students during construction. It will be designed to meet high performance certification and will aim for either LEED or CHPS.

This project is recommended for BEST Lease Purchase funding as follows:

Grant Amount - \$16,433,433.56; District Contribution - \$6,199,032.44 or 27%, with the source of match coming from the district's bond election which passed in 2017.

#### **Haxtun RE-2J / K-12 Roof Replacement & HVAC Renovations**

This project addresses health and safety by replacing leaking roofs over a large portion of the K-12 school and the HVAC system and controls in the high school. The existing HVAC is failing and controls are no longer functional or supported. This creates inadequate indoor air quality and temperature control, leading to classes being displaced or disrupted. The roof is no longer draining properly, and the existing roof membrane is leaking, causing interior damage. This project will enhance student achievement by providing a dry and thermally controlled indoor environment, with new HVAC units, central control system, and both EPDM and metal roofs where appropriate. The new roofs will have a 30-40-year rating.

This project is recommended for BEST Cash funding as follows:

Grant Amount - \$2,318,972.04; District Contribution - \$814,773.96 or 26%, with the source of match coming from financing through a utility cost savings contract.



### **Hinsdale County R-1 / PK-12 Security Addition & Renovation**

This project addresses health and safety by renovating the current 13,812 square foot facility and building on an addition of approximately 19,000 square feet. HVAC and electrical systems are in need of replacement and the facility lacks proper security and public announcement systems. The administrative areas do not have line of sight to the front entrance. Closets and entry vestibules are used as classrooms and hallways are used for storage. Hallways and doorways in many areas are too narrow and prevent the District's ADA accessible students from passing through safely. The facility does not have a kitchen. The District leases the town Armory, an unsecured facility with open-to-public access, for their gym needs located four blocks away or drives over an hour to access the nearest school gym in Creede. This project will enhance student achievement by renovating the existing facility to expand corridors, reconfigure classroom spaces, upgrade deficient systems, and provide adequate classrooms for special needs students. The new addition will move the administrative area to the front of the facility, and will provide space for a kitchen, library, art classroom, music and multi-use classroom, a gym, and an adequately sized commons/cafeteria. The renovations and addition will be designed according to high performance design criteria with sustainable principles and strategies.

This project is recommended for BEST Cash funding as follows:

Grant Amount - \$9,445,933.70; District Contribution - \$4,048,257.30 or 30%, with the source of match coming from the district's 2018 bond election.

### **Mesa County Valley 51 / Orchard Mesa MS Replacement**

This project addresses health, safety, and technology by replacing the original school that was constructed in 1960 as three separate buildings that has since evolved to be eight separate buildings. Most building systems are obsolete or non-functional. A number of different assessments concluded that the current school facilities were beyond saving. This project will enhance student achievement by constructing a single-building solution designed to support their pedagogy and current building codes. The new school will incorporate high performance design.

This project is recommended for BEST Cash funding as follows:

Grant Amount - \$13,969,263.00; District Contribution - \$25,942,917.00 or 65%, with the source of match coming from the district's 2017 bond election proceeds fund.

### **Harrison 2 / ES Security Entrances**

This project addresses health and safety by updating building entrances at 14 elementary schools. This project will enhance student achievement by providing a secured entrance through the addition of an isolated vestibule or modifications to hardware and operation of an existing security system. The new security system will be integrated into the district's overall security plan.

This project is recommended for BEST Cash funding as follows:

Grant Amount - \$439,318.32; District Contribution - \$439,318.32 or 50%, with the source of match coming from the district's general fund.

### **Saint Vrain Valley RE-1J / Main Street School Renovation**

This project addresses health and safety by renovating a 93-year-old school in the heart of Longmont that is the district's center for special education students. The project will both restore the building and renovate it to better accommodate student needs, eliminate existing safety issues, and upgrade security, public address, and fire alarm systems. This project will enhance student achievement by improving the plan for better student



supervision, providing for accessible routes and toilet rooms, and changing details to eliminate building features that can be used for self-harm.

This project is recommended for BEST Cash funding as follows:

Grant Amount - \$2,246,065.01; District Contribution - \$4,999,305.99 or 69%, with the source of match coming from the district's 2016 bond proceeds fund.

#### **Atlas Preparatory School / HS Roof Replacement**

This project addresses health and safety by replacing an existing roof system that is currently leaking and no longer under warranty. This project will enhance student achievement by eliminating the disruption of a leaking roof. When there is a water event the school must relocate students. The school must then remove the water, repair damaged interior finishes and mitigate for mold. The existing roof system will be removed and replaced with a new built up roof that will be code compliant. The project will be designed for a 20-year life expectancy and will have a three-year construction warranty.

This project is recommended for BEST Cash funding as follows:

Grant Amount - \$457,104.42; Charter Contribution - \$331,006.65 or 42%, with the source of match coming from the school's capital reserve fund and a construction match by the Lane Foundation.

#### **Cañon City Re-1 / Cañon City MS Major Renovation & Addition**

This project addresses health and safety by renovating the historic 1925 portion of the Cañon City Middle School facility, the newer gym facility and by replacing the 1980 classroom addition. Several of the facility's major building systems are in need of replacement, and portions of the 1925 historic gym section have structural damage. Asbestos is present throughout the facility and in locations that are accessible by students. Security is lacking in the facility with numerous points of entry without proper access control. Accessibility issues are prevalent. This project will enhance student achievement by replacing the classroom portions, renovating the historically significant portion of the main facility, renovating the gym facility, and replacing failed building systems. The design will aim to achieve LEED Gold or CHPS Verified Leader certification.

This project is recommended for BEST Cash funding as follows:

Grant Amount - \$22,795,468.34; District Contribution - \$9,631,839.66 or 27%, with the source of match coming from the district's bond election passed in 2017.

#### **Montrose County RE-1J / Multiple School Hazmat Abatement**

This project addresses health and safety issues by abating hazardous materials located in five schools. At these schools, asbestos-containing materials ranging from ceiling tiles, floor tiles, and tack boards are present in student accessible areas and have sustained severe damage. In one school, a mercury gym floor remains and requires abatement and replacement. In addition, three of the facilities have live utility areas which are no longer accessible for maintenance due to damaged asbestos pipe insulation. This project will enhance student achievement by abating the hazardous materials to ensure students have a healthy and safe learning environment. The scope will include restoration of abated areas with new ceiling tiles, lights, flooring, and bleachers (necessary due to deteriorated condition).

This project is recommended for BEST Cash funding as follows:

Grant Amount - \$1,113,864.57; District Contribution - \$1,742,198.43 or 61%, with the source of match coming from the district's capital reserve fund.



### **Kit Carson R-1 / New PK-12 School**

This project addresses health and safety by replacing a deteriorated PK-12 school facility. The existing facility has a variety of deficiencies, including a leaking foam roof with asbestos containing ceiling tiles underneath, a failing sewer system with areas of broken and collapsed lines, poor indoor air quality, inadequate and inaccessible electrical distribution, water infiltration from poor site drainage, as well as numerous educational suitability deficiencies. This project will enhance student achievement by replacing the school facility on the same site. The project will target LEED Gold or CHPS Verified Leader certification.

This project is recommended for BEST Lease Purchase funding as follows:

Grant Amount - \$24,311,578.59; District Contribution - \$8,048,783.60 or 25%, with the source of match coming from a November 2018 bond election.

### **Hayden RE-1 / Junior-Senior HS Replacement and ES Renovation**

This project addresses health, safety, and technology by relocating the junior-senior high school to the same campus as the elementary school and renovating that existing school to accommodate current educational requirements. This new school will provide for all class levels in one place. The current junior-senior high school building is in poor shape, located along a highway that has resulted in cars running into the building, suffered structural damage from snow loads, and has layouts that no longer support current educational and school-safety guidelines. This project will enhance student achievement through colocation, maximizing the potential for integrated learning. The new facility will be designed to current educational and energy-code standards. The district anticipates lowering their operating costs by having just one campus to maintain versus two with a reduction in redundant staffing, utilities, and building and grounds maintenance.

This project is recommended for BEST Lease Purchase funding as follows:

Grant Amount - \$38,879,497.00; District Contribution - \$22,296,400.00 or 36%, with the source of match coming from the district's 2017 bond election proceeds fund.

### **Adams City 14 / Alsup ES Replacement**

This project addresses health, safety, and technology by replacing an existing 1959 elementary school with deficient systems, safety concerns, and layout that does not lend itself to current educational standards. This project will enhance student achievement by providing a new facility that will address student safety through site access and a building security plan, provide for safe and code compliant building systems and incorporating current and planned future instructional technology. The project will pursue high performance design for energy efficiency.

This project is recommended for BEST Lease Purchase funding as follows:

Grant Amount - \$19,650,133.78; District Contribution - \$14,229,407.22 or 42%, with the source of match coming from the district's capital reserve fund, unassigned fund balance and a Certificate of Participation the district will obtain.

### **Adams 12 / International School at Thornton Middle Roof Replacement**

This project addresses health and safety by replacing a roof that is leaking and no longer under warranty. This project will enhance student achievement by eliminating disruptions due to roof leaks. When leaks occur the school has to disrupt activities to relocate students. The district will then try to locate the leak, repair the roof, repair interior finish damage and remove the water and confirm that no mold has grown. The existing roof will





be removed and replaced with a graveled built up roof system that will have a life expectancy of 25 to 30 years. The roof will be installed per current building and energy codes.

This project is recommended for BEST Cash funding as follows:

Grant Amount - \$585,999.92; District Contribution - \$745,818.08 or 56%, with the source of match coming from the district's November 2016 successful bond election.

#### **Swallows Charter Academy / Modular Replacement**

This project addresses health and safety by replacing an array of existing modular buildings which house grades three through twelve. The 20-year-old modulares were installed in 2008 and intended to be temporary. They have indoor air quality issues, leaking roofs, and mechanical systems that do not adequately heat and cool. Detached modulares create a safety concern as the school is located adjacent to a retail facility and students move across the site. This project will enhance student achievement by providing a safe and secure, energy efficient building with daylighting, and a technology infrastructure that will provide for current educational opportunities. The project will be designed to current codes and consider high performance design.

This project is recommended for BEST Lease Purchase funding as follows:

Grant Amount \$19,680,496.15; Charter Contribution \$411,894.00 or 2%, with the source of match coming from the charter's general fund, capital reserve fund, Swallows Charter Academy Educational Foundation and Swallows Charter Academy COLOTrust fund.

#### **Alamosa Re-11J / AHS Security Upgrade**

This project addresses health and safety by improving security infrastructure. The front entrance is not secured or connected to the administrative area. The school does not have controlled access or detection systems in place, lacks appropriate interior and exterior way-finding signage, lacks capacity in the visitor parking area (which causes visitors to attempt to access the school from inappropriate locations), and has poor site visibility due to inadequate exterior lighting. This project will enhance student achievement by providing a properly secured facility. A security vestibule will be installed and the administrative area will be relocated to the front entrance with a window for proper screening of visitors. Door detection and keyless entry systems will be installed along with a few security cameras to monitor additional access points. Way-finding signage will be installed and proper site lighting will be installed.

This project is recommended for BEST Cash funding as follows:

Grant Amount - \$1,063,673.91; District Contribution -\$523,899.09 or 33%, with the source of match coming from the district's capital reserve fund.

#### **The Vanguard School / ES - HS Roof Replacement**

This project addresses health and safety by replacing an existing roof that is leaking and has exterior water damage. This project will enhance student achievement by eliminating concerns during a water event that the roof will leak. When the roof leaks students are disrupted and relocated to other areas of the building. School staff must then remove the water, repair interior and exterior damage and verify that no mold has occurred. The roof will be designed for a 20-year life expectancy and have a three-year construction warranty.

This project is recommended for BEST Cash funding as follows:

Grant Amount - \$174,284.93; Charter Contribution - \$196,534.06 or 53%, with the source of match coming from the charter's general fund.



### **Lamar Re-2 / HS and HOPE Center Mechanical and Security Upgrades**

This project addresses health and safety by replacing mechanical systems to improve indoor air quality, and heating and cooling deficiencies. Window replacements will also support the new mechanical system. Asbestos abatement will be addressed on the existing piping systems. And a new fire alarm system will be installed. This project will enhance student achievement by providing appropriate heating and cooling, upgrading the fire alarm system and providing an improved security system to support the district's security plan. The new mechanical system will meet current codes, be energy efficient and be designed such that the district can operate and maintain.

This project is recommended for BEST Cash funding as follows:

Grant Amount - \$4,429,262.47; District Contribution - \$3,927,836.53 or 47%, with the source of match coming from the district's bond election November 2018.

### **Archuleta County 50JT / HS Safety & Security Upgrades**

This project addresses health and safety by installing proper access control and a security vestibule. Currently, the facility lacks access control at its exterior doors and the administrative area is set back into the building with limited line of sight. This project will enhance student achievement by providing a safe and secure facility for students. A security vestibule with security station will be added to the main entry and door position detection will be installed on all exterior doors with keyless entry systems. Additionally, security cameras will be added to strategic locations.

This project is recommended for BEST Cash funding as follows:

Grant Amount - \$199,620.33; District Contribution - \$312,226.67 or 61%, with the source of match coming from the district's capital reserve fund.

### **Summit RE-1 / ES, MS, and HS Roofing and Heating, Air Conditioning, and Ventilation Repairs**

This project addresses health and safety by replacing or repairing roofs; replacing or repairing heating, air conditioning, and ventilation systems; replacing a hot water system; and shoring up the structural capacity of a roof. Seven schools will be improved. This project will enhance student achievement by eliminating the distractions caused by leaking roofs and on-going maintenance, being thermally comfortable while in the classrooms, and not being vulnerable to a potential roof failure in a heavy snow load. The district has engaged a roofing consultant, engineers, and other experts to provide long-lasting fixes.

This project is recommended for BEST Cash funding as follows:

Grant Amount - \$1,600,127.82; District Contribution - \$6,400,511.29 or 80%, with the source of match coming from the district's 2016 bond proceeds fund.

### **Ricardo Flores Magon Academy / New PK through Eighth Grade School**

This project addresses health and safety by replacing an existing facility that has many building deficiencies including a mechanical system that does not provide adequate heating and cooling, a leaking roof (prone to mold) site drainage issues, and security concerns with minimal ability to supervise access to the building. This project will enhance student achievement by constructing a new facility that will provide a safe, secure and healthy environment for the students. The new facility will be code compliant and energy efficient. High performance design considerations will be evaluated to provide a facility that the school will be able to operate and maintain.





This project is recommended for BEST Cash funding as follows:

Grant Amount - \$15,560,678.90; Charter Contribution - \$818,983.10 or 5%, with the source of match coming from an Open Space grant, gifts, donations and financing.

**Wray RD-2 / PK-12 Addition/Renovation**

This project addresses health and safety, security, and technology deficiencies by replacing a deteriorating middle school and renovating an existing elementary and high school. The existing middle school facility has a variety of deficiencies, including structural settling, mold and water damage, poor indoor air quality, fire safety concerns, inadequate electrical distribution, and a state highway directly bordering the open school site. The existing elementary and high school campus has security and access control concerns, mechanical air quality and noise deficiencies, and site safety concerns. This project will enhance student achievement by renovating the elementary and high school, and constructing a middle school addition on that site, connecting the district as a single PK-12 campus. The project will target CHPS Verified Leader certification.

This project is recommended for BEST Lease Purchase funding as follows:

Grant Amount - \$18,974,060.46; District Contribution - \$15,524,231.29 or 45%, with the source of match coming from a November 2018 bond election.

**Summit RE-1 / ES, MS, and HS Safety and Security Upgrades**

This project addresses health and safety by upgrading fire proofing, public address systems, fire alarms, access control, door contacts, security vestibules, and security cameras at eight schools. This project will enhance student achievement by providing teachers and students with the comfort of a more safe and secure learning environment. The district included first responders, community members, parents, teachers, and students in determining what improvements are best suited to their schools.

This project is recommended for BEST Cash funding as follows:

Grant Amount - \$1,232,781.39; District Contribution - \$4,931,125.54 or 80%, with the source of match coming from the district's 2016 bond proceeds fund.

**Mapleton 1 / Global Intermediate Academy Four-Eight School Replacement**

This project addresses health and safety by replacing an existing school facility. The district's educational model is small schools and this school will be a part of a PK-12 campus. Currently the PK-3 and 9-12 schools are under construction. The existing facility has many health and safety concerns including indoor air quality, thermal comfort, and security concerns—as the school is directly adjacent to a major road and there are numerous detached buildings. This project will enhance student achievement by constructing a new single facility with controlled access, building systems that will provide for thermal comfort of students, natural daylighting and a technology infrastructure that will provide the ability to incorporate technology. The building will be code compliant and consider high performance design.
