acknowledge our highly achieving Colorado ACT students.



1 Last year, we recognized 17 students that 2 earned a perfect 36 on their ACT composite score. year, that number increased by more than 30 percent and 3 represents the largest group of students with perfect scores on the Colorado ACT since 2010. 5 Although not all of these students could be 6 here today, we are pleased to have 21 of these scholars 7 with us to be recognized. These students exemplify more 8 than 54,000 11th graders who took, in Colorado, who took 9 the Colorado ACT last spring. 10 ACT is one of two college entrance exams used 11 by many colleges. State usage of the ACT has grown 12 13 substantially in recent years. And Colorado is now one of 20 states to provide the ACT to all juniors in public 14 schools. Colorado has pioneered the ACT for 11th grade 15 students since 2001. 16 17 This year 54,512 students took the Colorado The ACT test students on English, Reading, 18 ACT. 19 Mathematics, and Science. The Colorado ACT provides students of this state with a prospect to go to college 20 and get scholarships where they otherwise might not have 21 the opportunity or financial support. 22 Colorado is proud to honor this group of 23 students for their achievement and offers our heartfelt 24

congratulations for this accomplishment.
