The Audit Team, which is part of the Public School Finance Division, had a name change to the Field Analyst Support Team. This was done in part to reduce the cohesive portrayal of the team. Each member of FAST is here to support and train the districts so that they can maximize their funding rather than being solely a punitive entity as the word 'audit' is usually associated with. While FAST still performs compliance audits on every school district, they are working hard to educate districts on legislation, how to improve internal processes around the Student October Count, the At-Risk (Free and Reduced Lunch) Count, and Transportation as it related to the CDE-40, and also how to better prepare for each corresponding audit.

Things you should be preparing for in September:

Pupil Count:

- 8/1/2014 9/30/2014:
 - Review all schedules for Secondary students and verify full or part time status
 - o Identify all specialized student types (work study, Concurrent Enrollment, Gifted and Talented, etc) and gather supporting documentation
 - o Begin correcting any data errors for the Student October Count submission
- 9/15/2014:
 - Alternative Count Day Requests due to FAST
- 9/24/14:
 - o October Count Window opens
 - o Ensure accurate attendance taking
- 9/30/2014:
 - o ALPs created for first time early access kindergartners and 1st graders

At-Risk Count:

- 7/1/2014 10/31/2014:
 - o Generate and review Direct Certification lists
 - o Receive and review Free and Reduced Lunch applications and Family Economic Survey forms
- 8/1/2014 10/31/2014:
 - o Identify homeless, migrant, foster, runaway, head start, and all 'free lunch' qualified Students
 - Gather and maintain supporting documentation

Transportation:

- 8/1/2014 9/1/2014:
 - o Identify routes and maintain descriptions for each route, as well a route miles
 - o Obtain calendars for each route, district or otherwise, and make note of any cancelations throughout the year
- 8/15/2014:
 - CDE-40 was due to CDE
