Mandatory Assurance Form

Beginning in the 2015-2016 school year, and thereafter, Authorizers must adopt policies tracking student enrollment, attendance, and participation. Authorizers may document students' attendance and participation in education activities

in a manner the authorizer deems appropriate to support student learning. For examples, see the Student October Count Audit Resource Guide for 2015. All authorizers must provide an assurance to CDE of the authorizer's verification of the student's attendance and participation in the online program of school for the 2015/2016 school year, regardless of if the authorizer filled out an assurance for 2014/2015. The assurances need to be provided to the Office of Blended and Online Learning no later than Sept. 10, 2015. Annual submission is not required, however, resubmission is required if and when the authorizer wishes to change their count policy. The approval form can be located here.
