- The goal of this project was to expand knowledge about the types of violence and abuse experiences youth have via technology (e.g., social networking sites, texting on cell phones), and how the experience of such cyber abuse within teen dating relationships or through bullying relates to other life factors. The study's findings showed that more than a quarter (26%) of youth in a relationship said they experienced some form of cyber dating abuse victimization in the prior year. With regard to other findings on bullying experiences, the study showed that one in six youth (17%) reported being victims of cyber bullying. Fewer than one in ten youth reported perpetrating cyber bullying in the prior year.
