## **Discontinued Content Exams**

Rule 1CCR 301-101 3.03(4) stipulates that an applicant has up to **five (5)** years from the date of a discontinued content assessment to use a successful score for meeting endorsement criteria. This applies to all *current* endorsements only; administrator excepted, due to quality standard revisions and exam alignment. The following chart outlines all previous content exams.
