Requirements for a Professional CTE authorization/endorsement:

To be issued a professional CTE credential applicants must meet the requirements in sections # 1, # 2, and #3.

**Section #1: 24 semester hours (sh) of coursework from a regionally accredited institution in the areas listed below.
Coursework must be verified on an official transcript.**

*A total of six semester hours may be earned through verified related work experience (40 hours: 1 semester hour) and/or professional development (15 hours: 1 semester hour) within the last 7 years. If an applicant uses work experience to meet coursework requirements that same work experience may not be used to meet requirements in other sections.

**Applicants who include a valid current state or national industry license or certification for the appropriate skill or trade area may have the coursework waived by the Colorado Department of Education.

Section #2: 2,000 or 4,000 hours of verified occupational experience

Section #3: CTE Coursework as assigned from the initial credential below.

Section #4: For licensure applicants only, the Technology Education PLACE exam or Colorado testing requirements for licensure must be met.

Initial CTE Authorization (For applicants not meeting professional requirements)

Applicant must meet the requirements below to receive an Initial CTE Authorization in this area and is allowed three years to fulfill the professional authorization requirements:

1. 18 semester hours of related college coursework (refer to section #1 above)
2. 50% of verified occupational experience hours (refer to section #2 above)

Please be advised that the Initial CTE Authorization cannot be renewed. In order to move from an initial authorization to a professional authorization you will be assigned:

1. Additional 6 semester hours of content related coursework to reach the required 24 hours if the applicant is missing hours,
2. Either 4 semester hours of CTE related coursework for licensure applicants or 6 semester hours of TAP for authorization applicants (see section #3 below),
3. Any additional occupational experience required to meet the 2,000 or 4,000 hour requirement,
4. For licensure applicants only, meet Colorado testing requirements for licensure.

The applicant has three years to meet these requirements and submit all documentation to CDE with a new application for a professional endorsement.

Section #3: Coursework to be assigned when initial CTE authorization is issued. Applicant has three years to complete the assigned coursework requirements. Coursework can be completed through approved courses only and must be documented on a college transcript. ***Licensure vs Authorization, What’s the Difference?**

All secondary instructors in Colorado are required to have either a license or authorization to teach. Schools districts vary in their requirements. Some districts require all instructors to be licensed while others accept those with either a license or authorization. **Licensure** requires the completion of an approved educator preparation program or alternative teacher licensing program. In addition, licensure applicants must also provide evidence of a passing score for their [content area assessment](#).

In 1991, the state legislature created an **Authorization** option for instructors in specialty areas not meeting the licensure requirements. The authorization requires the applicant to meet the credentialing/endorsement criteria which does not include content area exam or completion of an approved educator preparation program. Applicants will need to determine which path is appropriate to their specific case and submit either the Initial CTE Authorization Application or Initial Licensure Application.
