<p>Colorado Community Mental Health Centers (CMHCs)</p>	<p>Colorado's Public mental health system currently includes seventeen (17) Community Mental Health Centers (CMHCs), five (5) Behavioral Health Organizations (BHOs) and six (6) specialty clinics. The Colorado Department of Human Services, Division of Behavioral Health, contracts with community mental health centers to provide mental health services to non-Medicaid recipients. CMHCs are part of Colorado's BHO system. <p>Colorado Division of Veterans Affairs</p>	<p>The Colorado Division of Veterans Affairs is within the Colorado Department of Military & Veterans Affairs. It is the state agency that is mandated by state statute to assist veterans and their family members and survivors in securing any benefits they may be entitled to because of service in the military. <p>Colorado Community Centered Boards (CCB)</p>	<p>Colorado Community Centered Boards are private non-profit organizations designated in statute as the single entry point into the long-term service and support system for persons with developmental disabilities.
