### **READ Act**

As part of a change to the READ Act, all kindergarten through third-grade teachers will be required to submit evidence of completing a training in scientifically or evidence based practices in reading. CDE will provide training to teachers at no cost to support the completion of this requirement. Registration information for CDE's training options are posted on the <u>K-3</u> <u>Teacher Evidence-Based Reading Training</u> <u>Requirements webpage</u>.

The READ Act requires the department to identify quality instructional and professional development programs for use by local education agencies. CDE has posted links to providers and programs that have been identified through the <u>2020</u> <u>instructional programming review process</u>.
