

The successful implementation of standards-based education practices compels educators to embrace a continuous improvement cycle that focuses on effective teaching and learning practices through planning, doing, reflecting, and revising.

The Office of Standards and Instructional Support's Implementation Plan exemplifies this continuous improvement cycle at all levels of the educational system: classroom, school, district, and state department of education. We began with standards readiness to increase the standards literacy of all educators in professional learning modules 0-7. If you haven't done so, please work through each of these modules.

- 4. What do we do when students are not learning or reaching mastery of grade-level standards before expected?
