**Dependencies:** Each staff has been assigned an Educator Identifier (EDID) and updated through the Educator Identification System (EDIS). Each EDID is also reported in the Staff Interchange for the reporting LEA. The Local Course Code has been mapped to a State Standard Course Code with the SSCC interchange.

**Record Expectation:** In the Teacher-Student Data link Interchange file, the LEA should submit one record for each unique course, section, and staff for the reporting LEA of any courses held with students enrolled in the selected school year.


**EDID** - An eight(8) digit numeric field containing the 8 digit value assigned by CDE to the Educator.
