

2016-2017 Special Education End-of-Year Snapshot

Purpose:

The purpose of the Special Education End-of-Year Snapshot is to obtain data on students who were referred, evaluated, and/or received special education services at any point during the reporting period.

Dependencies:

- Student has been assigned a SASID and/or a LASID.
 - If a student is in a district's jurisdiction the student will be assigned a SASID which is updated in the RITS system. The LASID may be filled in or zero-filled on these records.
 - If the student is not part of a district they will be assigned a unique LASID by the Admin Unit, and the SASID will be zero-filled.
- Special Education Students will be tracked through the Special Education IEP Interchange.
 - Student has a record in the Special Education Participation file.
 - Student has a record in the Special Education Child file.
- Special Education Students who are part of a district will have records in the Student Interchange.
 - A student within a district's jurisdiction will have a record in the Student Demographic file.
 - A student within a district's jurisdiction will have a record in the Student School Association file.

Criteria:

For a record to be added to the Special Education EOY Snapshot it must:

- be included in both the Child and Participation Files
- contain a matching SASID (and/or LASID) in both the Child and Participation Files
- be error free in both the Child and Participation Files

*All records that meet the above criteria will be pulled into the snapshot **EXCEPT** those with a PAI code of 23, 24, 31, or 32 or a Special Education Part C Referral code of 00.

Notes:

- The Student Interchange is the primary source for SASID, LASID, Student's First Name, Student's Middle Name, Student's Last Name, Gender, Date of Birth, Ethnicity, Race, and Grade Level.
- If the record is not submitted in the Student Interchange, the demographic fields listed above will be pulled from the Special Education IEP Interchange.
- The Special Education Child, Participation, and Student Interchange files will be joined based on the following criteria: SASID, LASID, School Year, Admin Unit (or district), and error free records.
- Data pulled from the Student Profile Interchange will be the non-tagged data.

Note: The primary key for the Special Education End of Year Snapshot aligns with the primary key for the IEP Interchange and Student Interchange.

This designation is based on the race and ethnicity information provided to the reporting district by the student (or his or her parent/guardian) or staff member.
