Special Education Discipline

Snapshot Business Rules Guidance



Overview

Business Rules are edit validations that are in place to ensure the data reported meets specified reporting requirements. There are two types of Business Rules that run at the time of the Snapshot:

- 1. **Errors** require resolution in order to finalize the snapshot
- 2. Warnings data should be reviewed, but are not required to be resolved in order to finalize the snapshot

Business Rules

Below are the Special Education Discipline Business Rules and guidance around how to resolve.

BUSINESS RULE:		HOW TO RESOLVE:
SD001	Special Education Removal Type is required if Suspension/Expulsion is zero.	Error triggers when the 'Discipline' field is zero-filled. If record is indeed a 'Removal' instead of a Discipline report: • 01 Unilateral Removal by School Personnel for Drugs/Weapons/Serious Bodily Injury OR • 02 Unilateral Removal by Hearing Officer in the 'Removal' field and add a 'Removal Type' to indicate Drugs, Weapons, or Bodily Injury. If the record is actually a Discipline • 01 In-School Suspension OR • 02 Out-of-School Suspension OR • 03 Expulsion) or Both report the applicable Discipline code and zero-fill the Removal and Removal Type fields.
SD002	Discipline Action Length cannot exceed 260 days for a student.	Be sure 'Discipline Action Length' total for a student is not more than 260 days. Length should total number of school days missed.
SD003	Birth Date calculated age must be greater than or equal to 3 and less than 22 as of December 1st for this school year.	File should only include students whose birth date is greater than or equal to 3 and less than 22 as of December 1st
SD004	A child cannot be reported with a Primary Disability of Developmental Delay if they were 9 or older as of December 1st of this school year.	The student's Primary Disability cannot be Developmental Delay/code 11 if the student was 9 years old or older as of December 1st.
SD005	Record must be included in the snapshot. This field is blank because a matching record could not be found in the Student Profile Interchange.	The SASID comes from the Student Profile file. You can check the status of the Student Profile file by going to COGNOS Special Education Discipline "District Activity Report". You will be able to see if a file was successfully uploaded. You may need to

		free at the interchange.

	RULES WHICH MAY	REQUIRE AN EXCEPTION
SD020	Student's age is outside of the valid range for the reported grade.	An exception that explains the reason the student's grade is outside the acceptable range for their age. Please see instructions for reporting an exception under Additional Links .
SD024	The Discipline Date should fall between the Dates of Entry and Exit of Special Education in the IEP Participation file. First check to be sure student is included in your Participation file with up-to-date entry and exit dates and is error free. If so, did the student exit your AU after this Discipline Action occurred? If yes, please submit an exception request.	First, check to be sure the record is included in the Sped Participation file and is error free. Next, verify the Sped entry and exit dates are correct and contain the latest attendance information within the school year. A student may have exited earlier in the school year, and returned at a later point. If the discipline event did not occur during the current attendance, an exception is required. Please see instructions for reporting an exception under Additional Links.
