## Background

### Federal and State Law Governing Data Reporting Requirements

- CDE collects certain data to meet the requirements of specific federal and state laws. State Law requires student-level data for the purposes of:
  - District and school accountability
  - Program enrollment
  - Financial allocations
  - Calculating individual student growth percentiles
- Federal Law requires aggregate data (no student-level information ) for the purposes of :
  - Schools and district performance reports for parents
  - Evaluation of specific programs
  - Program Federal Funding, that include:
    - Special Education
    - Free/Reduced Lunch
    - English language learners (ELL)

*CDE does not provide any collected individual student data to the federal government.*

### Federal and State Student Privacy Laws

The Colorado Department of Education has student privacy procedures that fully adhere to the guidelines set forth in [Federal and State law](#), but CDE includes additional safeguards such as:
