

New State Assigned Student Identifier Reporting Requirements Expelled and At-Risk Student Services

What is a State Assigned Student Identifier (SASIDs) Number?

Grantees are responsible for compiling a list of SASIDs for all students served by the Expelled and At-Risk Student Services (EARSS) grant for the Mid-Year and End-of-Year reporting. The SASID is a 10-digit number assigned to students to enable CDE to conduct detailed analysis of student characteristics and performance over time.

General SASIDs Reporting

Each student served should have a SASIDs number which will be reported on the SASIDs excel file. For the 2016-17 Mid-Year and End-of-Year evaluation, the format of the SASIDs excel file will remain the same (*See screenshot below*). Like in previous data collections, grantees will continue to fill out the yellow shaded area and columns A, B, and C. For each student served, grantees will report their 10 digit SASIDs number (column A), their date of birth (column B), and their student type using the “Student Type Legend” (column C).

New Requirements for SASIDs Reporting

Moving forward, the EARSS Program is requesting that columns D (Attendance Interventions), E (Behavior Interventions), and F (Course Completion Intervention) are also filled out (*See screenshot below*). For each student, indicate whether the student received attendance interventions, behavior interventions, and/or course completion interventions with “1.” If a student did not receive a specific intervention, the cell can be left blank. All students should have at least one intervention selected.

Example SASIDs File

Here is an example of how to fill out the SASIDs form. In this scenario, Grantee X served 6 students:

- *Two of the students were at-risk for expulsion:* One of these students received attendance, behavior, and course completion interventions. The other student only received behavior interventions.
- *Two students were expelled:* One of these students received attendance and behavior interventions. The other student received course completion.
- *Two students were at-risk for habitual truancy:* The two students received only attendance services.

The below image shows what the SASIDs excel file would look like for Grantee X:
