# **News and Updates**

## Congratulations to the First Ever Educational Stability Grantees!

In 2018, Colorado passed House Bill 18-1306; Concerning Ensuring Educational Stability for Students in Out-of-Home Placement. This bill included the creation of the Educational Stability Grant Program, which is intended to support educational stability of highly mobile students. In this context, highly mobile refers to students who experience (or are at risk of experiencing) multiple school moves during their K-12 education outside of regular grade promotion. This includes youth in foster care, those experiencing homelessness, and migrant students. The intent of the Educational Stability Grant Program is to provide academic and social-emotional services and supports to highly mobile students. The purpose of this funding opportunity is to remove educational barriers and support educational stability. The emphasis is on improving school attendance, reducing behavioral and discipline incidents, increasing grade-level promotion, reducing dropout rate, and increasing graduation and completion rates.

Congratulations to Jeffco Public Schools and the Colorado Action Lab at the University of Denver in the release of the "Fostering Opportunities" program manual. Fostering opportunities is an innovative student engagement program for middle school and high school students who have experienced foster care. The goal of the program is to help young people who have experienced foster care be successful in school and ultimately earn a high school credential. This program is aligned to the standards for the Title IV-E Clearinghousethat sets the bar for evidence-based interventions under the Families First Prevention Services Act. #### Colorado Selected to Represent in the First Cohort for State Support Network Community of Practice

The Foster Care Education Program at CDE was selected as one of 12 states to participate in a cohort of State Education Agency Foster Care Points of Contact by the Office of Elementary and Secondary Education State Support Network. The Foster Care CoP will convene a cohort of SEA POCs who have demonstrated emerging expertise in the implementation of the ESEA's educational stability provisions. CoP participants will share best practices, develop resources to overcome implementation challenges, and identify additional technical assistance needed to effectively implement these ESEA provisions.

#### Accessing Transportation Funds for Students in Foster Care

CDHS will continue to assist counties and school districts in accessing reimbursement dollars allocated for foster care education. If your school district has established a reimbursement procedure, please continue to follow that plan this year. If a plan for reimbursement is still in negotiation, school districts may bill CDHS directly. Please note: the definition of out-of-home placement is not inclusive of kinship placements where the county does not have legal custody. CWELs may contact the educational points of contact at the county (see above link) to inquire as to whether or not the county has legal custody.
