- FAFSA Applications: Are you providing Unaccompanied Youth with a letter verifying their status?
- Site visits and monitoring will be scheduled with selected districts this spring
- Are you tracking birth-2 year olds? 3-5 (not kindergarten)? These subgroups will be collected for the 2017-2018 school year. Contact your State Coordinator if you need assistance.

## **McKinney-Vento 2016-2017**

State 4-year Graduation Rate = 79.0%

Graduation Rates for Students Experiencing Homelessness

- 4-year – 55.8%
- 5-year – 60.1%
- 6-year – 63.9%
- 7-year – 65.2%

*These cohort rates represent the number of students receiving a diploma within 4,5,6, or 7 years of completing 8th grade*

State Annual Dropout Rate = 2.3%

Annual Dropout Rate for Student Experiencing Homelessness = 5.9%

Represents 557 students (out of 9,459 identified as homeless)

*This annual rate refers to the number of students in grades 7-12 who were reported as dropouts and "age outs during the past year.*
