Every Student Succeeds Act (ESSA) highlights the requirement for Liaisons to participate in and conduct ongoing professional development that enhances knowledge and skills within the McKinney-Vento program. US Department of Education Survey

Be on the lookout for an email and a link to complete the 2017-2018 Data Collection Survey. There are a few changes this year: (1) Districts **are not** required to submit K-12 student counts. This information will be pulled from End of Year Reports. (2) Districts **are** required to submit Birth-2 and 3-5 (not Kindergarten) counts. This will be an informal collection, as this subgroup will not be identified through SASIDs.
