2019-2022 Education for Homeless Children and Youth Grant RFP released

The McKinney-Vento Education of Homeless Children & Youth Request For Proposal (RFP) is now available. The intent of the grant program is to remove educational barriers facing children and youth experiencing homelessness, with emphasis on educational enrollment, attendance and success.

Approximately \$600,000 is available for the 2019-2020 school year. Based on available funding, established need and quality of the proposal, three-year grants will be awarded, ranging from \$20,000 to \$60,000 per year for LEAs or BOCES.

Description: In this 45-minute NCHE webinar, presenters explore the issue of doubling-up. *Doubled-up* is the informal wording used to describe a concept included in the McKinney-Vento Act's definition of *homeless*. It refers to shared living arrangements, some of which may be considered homeless, while others may not be, depending on various factors. In this session, attendees will explore some of these factors in greater detail. Attendees also will have the opportunity to interact with presenters and fellow attendees through polls and Q&A/discussion periods.
