Supplemental Resources to Re-engage Out-of-School Youth

July 17, 2014

Sense of Urgency

- State statistics show that each year approximately 10,000 students will drop out of Colorado public schools.
- Only a third of Colorado dropouts actually re-enroll in school or receive a GED the year following the dropout event, and fewer than one in five remain enrolled or complete high school.
- Dropout recovery rates for students over 18 years of age are significantly lower than for younger students.

Re-engagement Priority

- In Year 5, CGP priority is to increase student reengagement to ensure that out of school youth reenroll and reengage in school.
- In this context, *student re-engagement* means that a student re-enrolls in school after dropping out in the past two years or within the current school year. Student re-engagement can be facilitated through a local education provider's use of evidence- or research-based strategies to reach out to students who have dropped out of school and to assist them in transitioning back into school and obtaining a high school diploma or certificate of completion.

Supplemental Resources

- \$100,000 in supplemental funding to CGP schools to serve an additional 100 youth who are classified as out-of-school.
- Supplemental Funding Goal: To re-enroll a total of 100 out-of-school youth. Of these youth, 50% will progress in their education or graduate.
- Regional pilot(s) of a student re-engagement center (including partnerships with districts, workforce centers, adult education and community-based organizations)
- Developing and supporting innovation in dropout recovery and outreach
- Special networking events
- Distribution of research

Process: Application Supplemental Funds

- **July 25:** CDE's application form finalized
 - CGP systems change and capacity-building schools, in "good-standing" are eligible to apply.
 - Application will including establishing deliverables to be added to Year 5 Scope of Work (SOW)
 - It is anticipated, 5 to 8 districts will be awarded supplemental funds.
- **July 28:** Projected date for application release
- Applications due date: **August 15**
- CDE Review of applications for supplemental funds: (TBD)
- **September 2014:** Distribution of supplemental funds to be added to Year 5 cooperative agreement



Action Steps:

- Identification of Need
- Identify, expand and/or enhance strategies
- Establish cost per unit of service (Estimated costs = \$500 to \$2,000 per out-of-school youth)
- Set targets for number of students to be served.
- Setting performance measures for re-enrollment, re-engagement, progressing to the next grade and graduating.

Defining Out-of-School Youth

Defining Out-of-School Youth for the Supplemental: Focus on three categories of out-of-school youth

- 1) Youth who have withdrawn/transferred to attend another school or GED prep program and never enrolled in school nor obtained a GED.
- 2) Youth (7th to 12th graders) who left school without a diploma or GED and are not currently enrolled.
- 3) Youth who self-identify as dropping out of school and want to re-enroll.

Dropout Prevention Framework Interventions and Strategies

Dropout Recovery and Re-Engagement

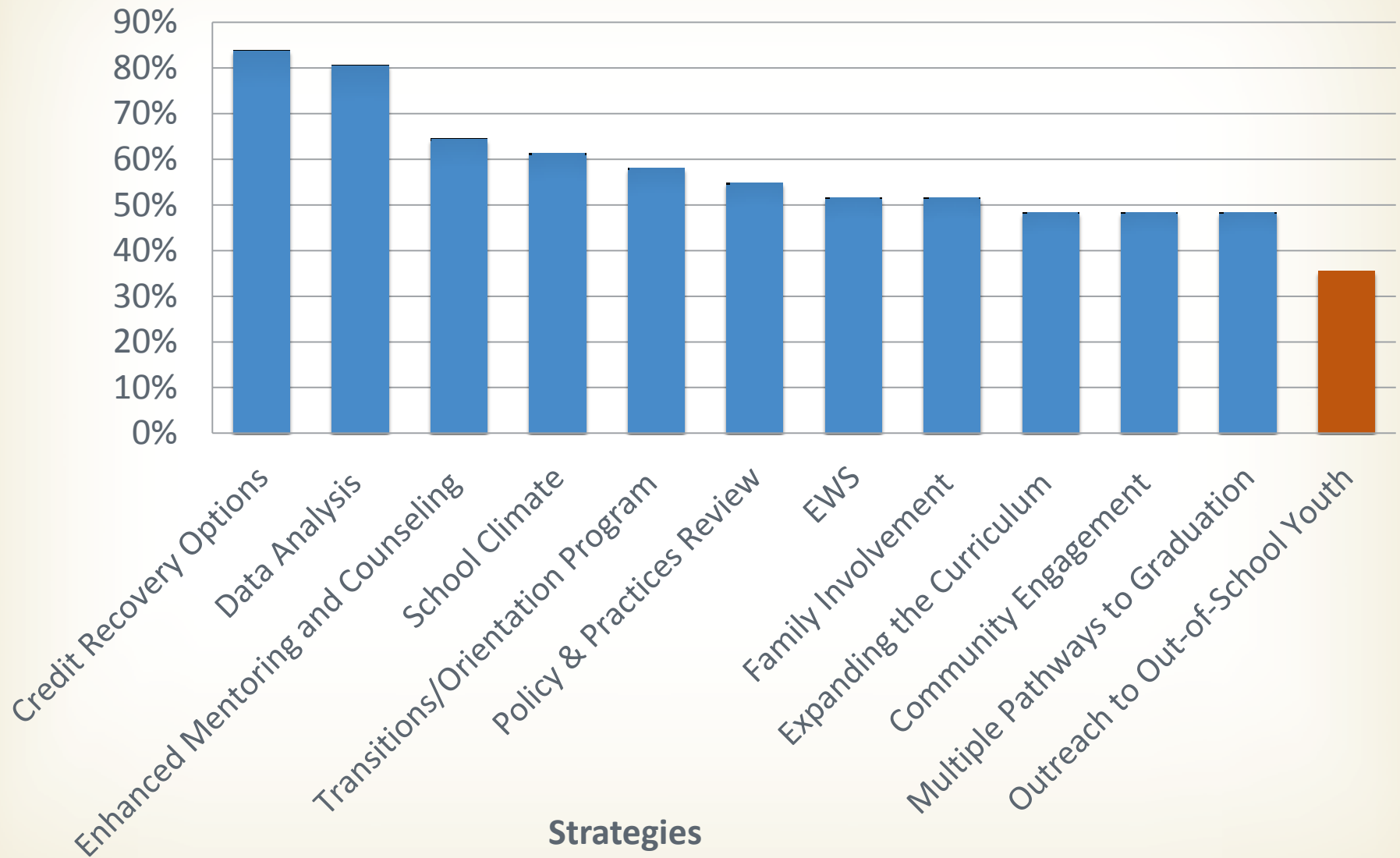
Research has shown that dropout recovery is more of a process than a discrete program.

It can be viewed as a continuum of services and strategies starting with the identification of students who dropped out and resulting in high school completion/graduation of recovered dropouts.

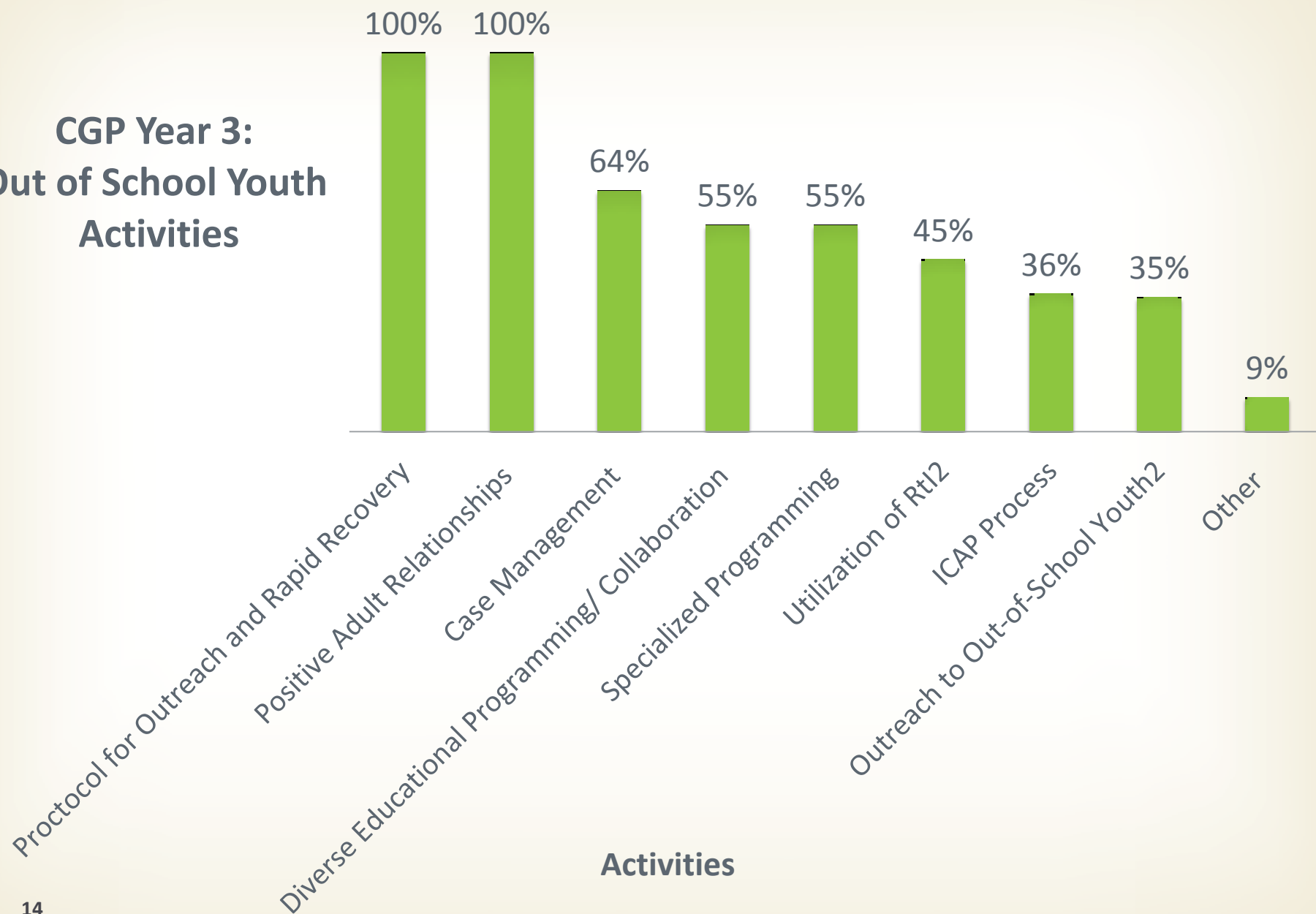
Outreach to Out-of-School Youth

- **Identification:** Outreach involves identifying and tracking students who have dropped out and re-engage them in a timely manner.
- **Set up systems for identification:** Identify and follow-up with students who have not attended school for a certain number of consecutive days and with students who have withdrawn in order to identify out-of-school youth on an ongoing basis.
- **Geographic Region:** Determine the most appropriate geographic regions or communities in which to target outreach efforts

Enhanced Mentoring & Counseling	<u>TIER 3 CASE MANAGEMENT</u> <ul style="list-style-type: none"> • Home visits • Bi-weekly multidisciplinary team meetings (includes: counselors, interventionist, administration, sometimes teachers) • Intensive Monitoring
Outreach to Out-of-School Youth	
Credit Recovery Options	<u>STRUCTURE & PRACTICES OF CREDIT RECOVERY</u> <ul style="list-style-type: none"> • Offered outside the regular school day/year • Offered during school day (online) • Credit Recovery option to advance in credits, not just to "catch up"
	<u>PERSONALIZATION OF THE CREDIT RECOVERY PROCESS</u> <ul style="list-style-type: none"> • Develop one-on-one relationships with students that are specifically in the Credit Recovery program • Make tutors available during Credit Recovery class • Designate a Credit Recovery point person to answer questions for students/parents or other service providers that may be working with the student • Develop tracking system (easy for students to use) and goal setting sheet. Point person or tutors work collaboratively with students to complete these sheets on continuous basis

Montezuma-Cortez High School	<u>Transition Coordinator</u> <ul style="list-style-type: none"> • Track and locate all unregistered 8th graders to discuss enrollment options
NAS- Thornton and NAS- Lowry	<ul style="list-style-type: none"> • Targeted outreach to students who have dropped out in the last two years to discuss reenrollment • Home visits; • Phone calls
Fort Lupton High School	<u>Retention Coordinator</u> <ul style="list-style-type: none"> • Review of all students who have dropped in the past two years • Contact/meet with students who have dropped out to review options
Englewood - Colorado Finest Alternative HS	<u>Outreach Specialist</u> <ul style="list-style-type: none"> • Consistent calls to students who already have dropped out/review options
Hidden Lake HS Westminster HS	<p>Direct student contact and tracking (summer dropouts). Conducted by school counselor and administration.</p> <ul style="list-style-type: none"> • Home visits; • Phone calls • Investigation through accessing information of the student body • After hours available for students who have dropped out (credit recovery) • Additional counseling services for students who have dropped out

Fort Lupton High School	<u>Retention Coordinator</u> <ul style="list-style-type: none"> • Review of all students who have dropped in the past two years • Contact/meet with students who already have dropped out to review options
NAS- Thornton and NAS- Lowry	<ul style="list-style-type: none"> • Targeted outreach to students who have dropped out in the last two years through calls and house visits to discuss reenrollment options and provide advice for those considering re-enrollment
Northridge High School and Central High School	<u>At-Risk Facilitators</u> <ul style="list-style-type: none"> • Increase rate of re-engagement for out of school youth through outreach to discuss options

FAQ: Students

1. What counts as re-engagement?

- See definition on slide 3

2. How is out-of-school youth defined?

- Youth who have previously left the educational system. For example, if a student has been out of school since last spring, and left without completing the educational term, than that student is an out-of-school youth. See slide 12 for more information

3. Do the students have to have dropped out of a CGP school to receive outreach services?

- No. Outreach services that are funded by the supplemental dollars can be used for any youth in the targeted region.

4. Can the funding be used for only re-engaged students, or for all students participating in the new/expanded strategy?

- Supplemental funds can only be used to support re-engaged youth.

FAQ: Strategies

5. Do we need to propose a new strategy, or can we expand an existing strategy?

- The supplemental dollars can be used for either expanding and/or enhancing an existing strategy regarding re-engagement of out-of-school youth, or creating a new strategy to re-engage out-of-school youth.

6. Should the funding be used for outreach only, or for outreach as well as support once students are re-enrolled?

- Supplemental funds can be used for both outreach as well as support once students are re-enrolled in a CGP school.

7. Will we need to do anything different to track this work?

- There will be additional reporting requirements, such as the tracking and reporting of SASIDs (State Assigned Student Identifiers) of the re-engaged students served through supplemental funds. Additional details will be included in the application.

FAQ: Application Process

8. Do the students have to be re-enrolled at a CGP school in order to use the supplemental funds?

- Supplemental funds can be used for outreach and re-enrollment support regardless of where the student enrolls at. Supplemental funds can only be used to support the on-going engagement of students who re-enrolled at the CGP schools.

9. Should we add the expanded or new strategies to our existing SOW or submit a new one?

- Districts will submit a separate form for the expanded or new strategies.

10. How will we access the forms to apply for the supplemental funds.

- The application forms will be available on July 28, 2014. They will be posted to the CDE Colorado Graduation Pathways/Grant Management site.
