Re: Comparability 2016-17

The Elementary and Secondary Education Act (ESEA), as authorized by the Every Student Succeeds Act (ESSA), states that the purpose of Title I, Part A is to "provide all children significant opportunity to receive a fair, equitable, and high-quality education, and to close educational achievement gaps." The requirement that Title I, Part A funds supplement, and not supplant, state and local funds is a longstanding provision of ESEA, intended to ensure that federal funds provide additional educational resources that students and teachers in high-poverty schools need to succeed. Consequently, if Title I schools do not receive their fair share of state and local dollars before Title I dollars are added, Title I, Part A funds do not serve their intended purpose of providing additional educational resources needed to serve disadvantaged students.

We are approaching the time for the 2016-17 Comparability data collection. During 2016-17, as we await the finalization of USDE regulations and develop systems to comply with ESSA, CDE will not change the comparability data collection system or process. However, as Colorado develops its plan to implement ESSA in 2017-18, we are considering ways to make the comparability collection and process more meaningful for schools and districts and allow CDE to better support schools at risk for not being comparable. We welcome your ideas and feedback. Please think about the process as we go through the 2016-17 cycle and consider partnering with us to improve comparability under the new ESSA statute.

Included in this memo is a preliminary list of districts that, most likely, will need to demonstrate comparability in 2016-17. This list was compiled without benefit of enrollment numbers and could change as enrollment numbers become available and/or districts make changes to their Title I school assignments. For example, districts with fewer than 1,000 students do not have to demonstrate comparability, nor do districts with only one school per grade span even if that school receives Title IA funds. Title I schools with 100 or fewer students do not have to be comparable, although their data are used in overall calculations.

You are being sent this memo even if your district is not currently required to conduct comparability. We want to keep you in the loop in case your schools' Title I status changes and you are required to calculate comparability in 2016-17 or the future.

A first step in this process is for each superintendent to authorize a Comparability Respondent. Respondents from previous years are still in the system and do not need to be re-authorized. However,

if you do not already have a respondent or you need to assign a new one, complete and return the attached form.

CDE has scheduled the following training webinars for respondents and others whose help will be needed to compile the data. Please pass along this information to everyone in your district who might be involved in comparability data collection and reporting and encourage them to attend one of these Comparability 2016-17 sessions, as you want to have sufficient numbers of people trained for how the system works.
