The Accountability Spoke will be presenting to the ESSA Hub on Thursday, January 19, to review the accountability decision points delineated below:

- Minimum N and major racial and ethnic groups to be used for accountability purposes
- Other indicator to be added to the accountability system
- Long-term goals and interim measures to be used for accountability
- Methods and criteria to be used for identification and exiting of schools in need of support and improvement
- Assessing English Learners (ELs) during the first year in the U.S.
- EL Progress Indicator to be used in accountability

The purpose of the January 19th meeting will be for the Hub to provide final input and decisions on the options and recommendation being prepared for the State Board of Education (SBE) and the accountability section of the ESSA State Plan. The following information is being provided for your review in preparation for the meeting, wherein you will be asked to decide upon the options and recommendations being put forth.

Due to the volume and depth of information necessary in order to be prepared to make a final decision, we request that you review the following materials in advance. Some of the materials have been previously shared with the Hub and/or have been available on our website, as noted, which might be review for you. Those materials are being provided again in this packet for your convenience. Others are new, also as noted. Please review the materials, as you feel necessary, in order to be prepared to discuss and vote on decisions at the meeting.
