504	Section 504 of the Rehabilitation Act	Section 504 is a federal law designed to protect the rights of individuals with disabilities in programs and activities that receive Federal financial assistance from the U.S. Department of Education. The Section 504 regulations require a school district to provide a "free appropriate public education" (FAPE) to each qualified student with a disability who is in the school district's jurisdiction, regardless of the nature or severity of the disability. Under Section 504, FAPE consists of the provision of regular or special education and related aids and services designed to meet the student's individual educational needs as adequately as the needs of nondisabled students are met. UAP	Unlicensed Assistive Personnel	Unlicensed Assistive Personnel (UAP): Any person who does not have a nursing or medical license, who acts in a complementary role, and whom the registered nurse or physician authorizes to perform certain nursing or physician tasks, which the individual is not otherwise authorized to perform. For example, a school principal is licensed as an educator, but is not licensed to perform health care tasks. The UAP could be a secretary, school administrator, teacher, para-educator, therapist, bus driver, practical nurse, child care worker, or health aide. The UAP cannot train, redelegate, or ask any other person to perform any nursing task under any circumstances.
