

- Support an agreed upon coordinating entity (Colorado Education Initiative) with guidance from a Steering Committee and input from an Advisory Council
- Align funding for efforts with the recommendations of these coordinating bodies
- Align efforts across the state through content-specific work groups
- Provide a broader "network" to anyone interested in school health to connect and share resources

Develop shared policy priorities

- Continue to support and use youth health data collected and shared through Child Health Survey, Healthy Kids Colorado Survey, etc.
- Continue to develop and use a coordinated system to measure school health policies and practices (Smart Source) and limit the data collection burden on schools
- Continue to promote the use of health data for schools to drive programmatic decisions, identify student need and integrate into accountability

- Support coordinated and consistent funding/resources for staffing to support health/wellness
- Help to provide for unmet needs and resources related to health/wellness


- Produce a "one-stop" shop for information and resources related to the priority school health strategies


