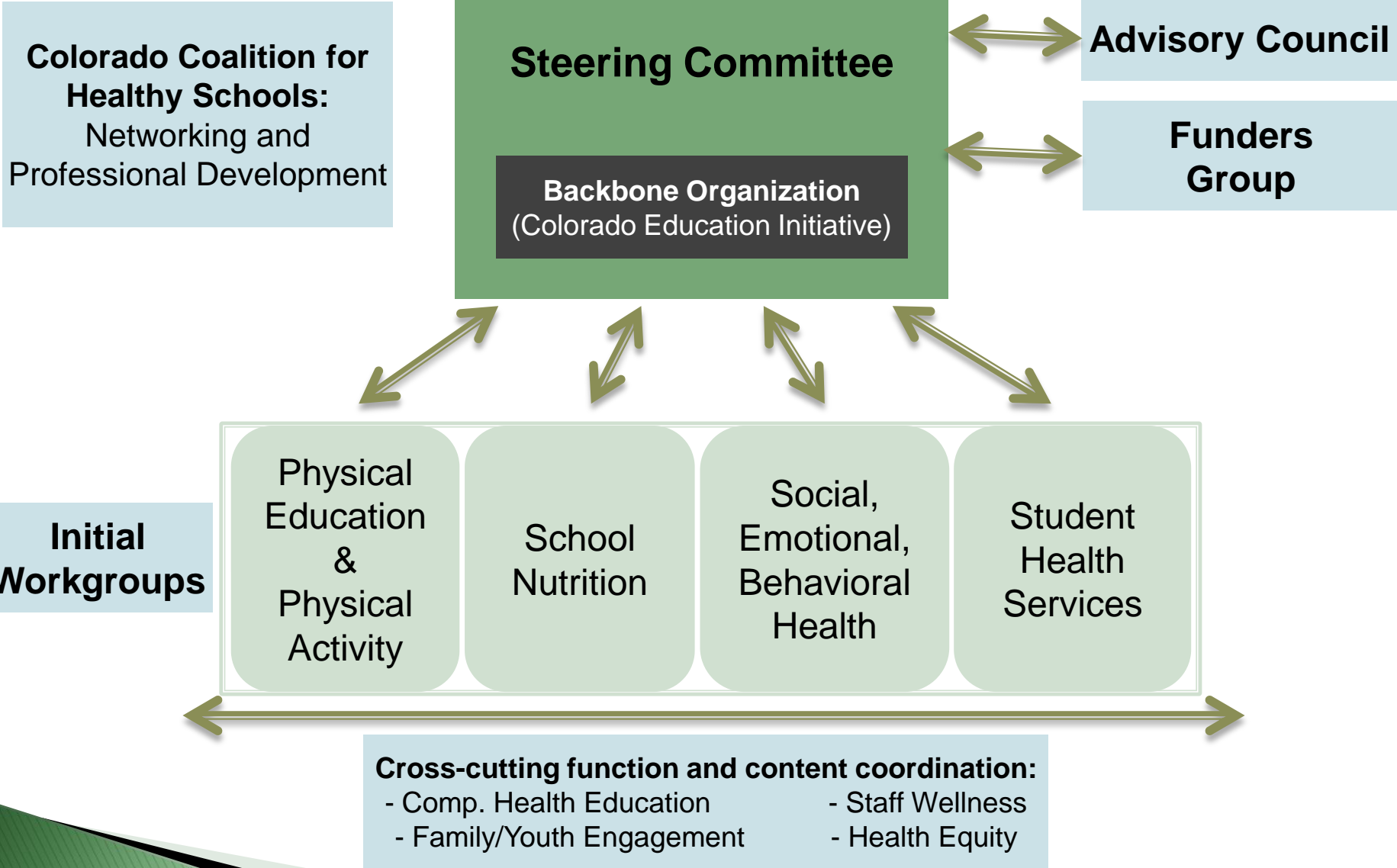


“What’s in it for me?”

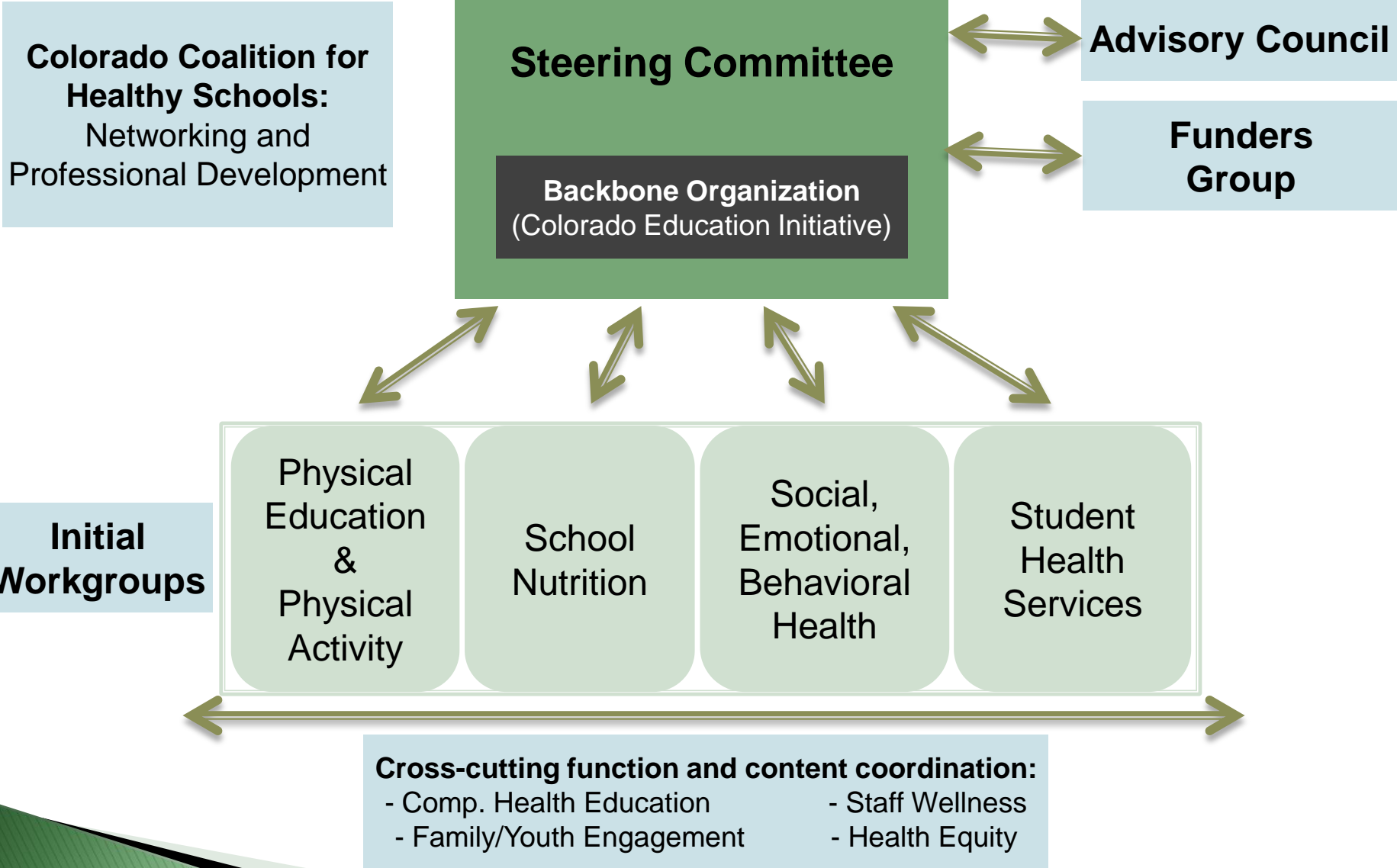

As part of this initiative we will:

Coordinate efforts

Engage those impacted by the work

Use consistent and agreed upon student and school **data**

Support core **capacity** for schools and districts

Develop shared **policy priorities**

Support consistent **communication**



What are the ways to be involved?

Tier I	Actively participate in one of the four work groups committed to prioritizing this effort
Tier II	Provide occasional content expertise, input, and guidance to work groups as needed
Tier III	Receive periodic updates (no further commitment at this time)



Tier I Commitments:

- Attend up to two meetings monthly (1-2 hours each) for nine to 12 months, beginning in October
- Review selected materials prior to meetings
- Arrive prepared for engaged discussion, active listening, and respectful dialogue
- Develop a common definition for healthy schools in Colorado
- Propose strategies to align resources, increase efficiency, decrease duplication, scale what works and lessen burden on schools to ensure their needs are met and gaps are filled
- Identify common measures for each work group
