Summary

University Preparatory Schools ("U Prep") currently consists of two campuses: Arapahoe Street and Steele Street. Arapahoe Street, the flagship campus, opened its doors to kindergarten and first grade students in fall 2011. Steele Street opened in August 2016 as a full K-5 turnaround. U Prep currently operates in Denver serving "high poverty, high needs students". U Prep has a track record of success at both campuses citing impressive data around family experience, teacher retention, language development and core academic outcomes. U Prep's application indicates they are "open to working with any front range districts with similar demographics" as their existing schools. The application provides clear information regarding their educational model, strategies for community engagement and processes for opening up new schools and partnering productively with school districts.

U Prep was founded in 2010 with the mission of "building a foundation of skills, knowledge and character, University Prep educates every scholar for a four year college degree and a life of opportunity." U Prep focuses on a "high poverty, high needs population." U Prep outlines key program components, major instructional methods, assessment strategies and core ELA and math practices.

Yes	U Prep has only operated in Denver Public Schools. U Prep is open to engaging in conversations with other districts but would need "autonomies necessary to run our existing program." In addition, U Prep would like access to get to know the families in the community that the school serves.

Yes	U Prep details a strong action plan for engaging with local communities citing efforts they have used in the past. Currently, U Prep employs two full time Community Engagement staff members "to manage outreach for current and future campuses." U Prep describes how they will approach community engagement for any future campuses. U Prep outlines potential areas where they could be financially creative with their model as well as the potential for additional outside sources to provide financial assistance. All of the sub-questions are addressed concisely and thoroughly in the application.
