School Nutrition Program Updates

Healthy School Meals for All

100%

Eligible sponsors opted in to HSMA

In the first year of HSMA implementation, all eligible sponsors operating Child Nutrition Programs opted in to the program which included 183 sponsors at 1,765 sites. Statewide, school meal participation saw significant growth, with breakfast participation rising by 37% and lunch participation increasing by 30% compared to the previous school year. Notably, the largest increases came from students who previously paid for their meals. Across Colorado, participation in school meals increased. As noted previously, breakfast participation increased by 37% and lunch participation year. With this boost to participation, sponsors reported highlights and challenges:



- Heightened excitement for school meals
- Feeding new students
- More charter school participation
- New, innovative service models to meet increased demand



- Staff and product shortages
- Supply chain delays
- Lack of time for students to eat
- Needing to update equipment and infrastructure to meet demand

Higher than projected school meal participation led to funding shortages for the program. In Spring 2024, the Joint Budget Committee voted on changes to balance the budget. These changes included:

- No change to meal reimbursements for 2024-25 School Year
- Delay grant and technical assistance programs
- Extend the Local Food Program pilot to 2024-25 School Year
- Create an Advisory Group to begin meeting in June 2024 to provide options for future legislation to balance program revenues and expenses
- Create a policy to increase collection of household income applications
- HSMA eligibility contingent on implementing CDE's recommended operating model for provisional programs, such as the Community Eligibility Provision

During Spring 2024, School Nutrition staff implemented several measures to prepare for the upcoming changes including mid-year CEP validation, determining how best to recommend operating models, and new, streamlined templates and resources for household income applications.





School Nutrition Program Updates

Summer EBT

100% Districts participating in data collection

In November 2023, state legislation passed to create the Summer Electronic Benefits Transfer Program that provides food benefits to students from qualifying households during summer months. Beginning Summer 2024, this permanent, annual summer program went into effect providing \$120 per eligible student on an EBT card to purchase groceries. CDE School Nutrition works with the lead agency, Colorado Department of Human Services, to provide training and technical assistance to schools and districts in their data collection to determine student eligibility. In the first year of implementation, 100% of districts provided the necessary data to ensure eligible students had additional access to nutritious foods during the summer months when they are not in school.

The Colorado Department of Human Services estimates \$66,000,000 in benefits were distributed across the state.

Direct Certification - Medicaid

Beginning with the 2023-24 school year, the Medicaid Direct Certification Demonstration project allowed districts to use Medicaid data, in addition to SNAP, TANF and migrant data, to match and identify students eligible for free or reduced-price meal benefits. This program, which is a partnership between CDE and the Department of Health Care and Financing, is anticipated to increase school meal access and participation and reduce administrative burden on districts and families. It is estimated to reach an additional 9,000 or more students each year.

Administrative Reviews & Technical Assistance Visits

Administrative reviews and technical assistance visits ensure program compliance, support program operations and provide guidance to strengthen meal programs.





Funding to Districts

USDA Equipment Grant

CDE School Nutrition administered the USDA Equipment Assistance Grant, which allows school food authorities to apply for funds to purchase new equipment, replace old equipment or renovate existing equipment. These funds support sponsors in providing healthier meals, enhancing food safety and establishing, maintaining or expanding the School Breakfast Program.



Local Food Program

TThe Local Food Program funds schools and districts to buy Colorado-grown, raised, and processed foods for Child Nutrition Programs. In School Year 2023-24, 87% of purchases were raw or minimally processed, and 13% were value-added products like tortillas and bread. Top local purchases included peaches, apples, melons, lettuce, tomatoes, cucumbers, beef, chicken, bison, and pork. Sponsors also prioritized Colorado-grown quinoa over other grains. Over half of grantees continued buying local foods beyond their LFP funding, contributing to an estimated \$2.2 million in local purchases—far exceeding the \$500,000 award. Sponsors showed commitment to increasing meal quality while supporting the the local economy, with an estimated \$851,837 economic impact.

School Nutrition also created an outreach toolkit for Healthy School Meals for All that includes talking points, flyers, social media posts and more to help educate about this new program.
