


National School Lunch Program & National School Breakfast Program

Sponsors and Sites for School Year 2022-23






Summer Food Service Program

School Nutrition Accomplishments

Healthy School Meals for All

In November 2022, Colorado voters passed a ballot initiative to create Healthy School Meals for All. This permanent program enables all school food authorities operating the National School Lunch Program and/or the School Breakfast Program to serve free meals to all students beginning in the 2023-24 school year. Additional components of the program available in the 2024-25 school year include funding to increase wages or provide stipends for front line kitchen staff and incentives to purchase local food.

- Offered multiple training opportunities beginning November 2022
- Passed State Board Rules in June 2023
- Created outreach materials for SFAs to educate school staff and families
- Maintained a detailed Frequently Asked Questions resource
- Made enhancements to the Colorado Nutrition Portal for SFAs to opt in





Direct Certification - Medicaid

In December 2022, the Colorado Department of Education was approved to participate in the Medicaid Direct Certification Demonstration project in partnership with the Department of Health Care Policy and Financing. Beginning in the 2023-24 school year, this project allows districts to use Medicaid data, in addition to SNAP, TANF and migrant data, to match students through the direct certification portal and offer free or reduced meal benefits to identified students. This program is anticipated to increase school meal access and participation and reduce administrative burden on districts and families. It is estimated to reach an additional 9,000 or more students each year.



School Nutrition Accomplishments

Training

School Nutrition provides training opportunities in a variety of ways - live webinars, on demand, and in person. In addition to two in person Rural Summits offered as part of the Blueprint to End Hunger Project, School Nutrition offered multiple professional development sessions during the 2022-23 school year.



Communication & Outreach

School Nutrition communicates important information and updates to sponsors and other stakeholders in a variety of ways. Two primary means of communication and outreach are The Dish, a bi-weekly e-newsletter, and the School Nutrition website. The Dish provides sponsors with upcoming deadlines, training opportunities and new resources for child nutrition operations. There are currently 1,318 Dish subscribers. School Nutrition launched a new website in January 2023, designed to provide a more user-friendly experience.

School Nutrition has created NSLP and SFSP outreach materials for sponsors to use with families, school staff and community members. Printed posters, banners, yard signs and window clings were made available to all sponsors at no cost. Downloadable outreach materials, available on the website, include menu and postcard templates, social media posts and web banners.








School Nutrition also created an outreach toolkit for Healthy School Meals for All that includes talking points, flyers, social media posts and more to help educate about this new program.



Needs Assessment

In February 2022, School Nutrition launched a comprehensive needs assessment to gather important feedback from child nutrition professionals across Colorado. Sixty-five percent of respondents were Food Service Directors. Additional respondents included site staff, managers, business officials and support staff. The results have informed School Nutrition's strategic and program planning for the coming years.



Respondents by Student Enrollment

The range of Colorado's diverse school districts were represented, with more than half of respondents from small, rural communities.

Qualitative Feedback

Respondents provided extensive qualitative feedback via comment sections. This data was analyzed and categorized into three primary areas of need:

- Training & Resources
- Improved Processes
- Marketing & Outreach

Key Findings

- 88% of respondents felt their School Nutrition Point of Contact provided effective customer service, while 12% had not used their Point of Contact
- 80% of respondents use The Dish and the website as primary sources of School Nutrition information
- Over 60% of respondents indicated on-demand and live webinars were their preferred modes of training; 40% reported a regional, in person model is preferred


Putting Data into Action

Based on the results, School Nutrition has prioritized multiple future action steps, including:

- Promote existing resources to support training, compliance and marketing needs
- Strengthen ACSN as a resource to sponsors
- Balance on-demand trainings and webinars with regional trainings to meet varied needs across the state
- Strengthen and grow the Point of Contact model
- Continue successful launch of HSMA with resources, training and outreach materials
- Additional support for meal quality and local food initiatives
