- Question from Woody Longmire about tabs on his district's SIS (CEPA and WBL) and asked: Is this where CDHE is getting CE data? Michael confirmed CE data is pulled from institution's data. Sarah said SIS vendors are adding on these pieces for different reasons. Recommends districts find out more internally.
- Question from Madeline, BVSD: Is there any benefit to separating out data between CE and dual and doing similar research for dual? Per Michael, it would be great to look at both sets of data, but CDHE would probably need another grant to do the research on dual.

COVID-19 Updates from CDE, CDHE, CCCS

- -Andy: Acknowledges the challenges K12 is facing. Hearing many concerns about drops in enrollment. Too early to know right now. Have not heard concerns with CE. Sounds like schools have adjusted to the shift to online CE though understand the struggle for teachers to teach both in-person and online.
- -Carl coming in a little later from another meeting.
- -Tammy: CCCS CE enrollment only down 3%. Recognized the amazing work and effort that was done in the spring to make sure students were able to complete courses. Andy agreed and asked if David and Chico would also share.
- -David shared from a student perspective that being in a small school has meant being inperson with masks. Preparing for the worst, hoping for the best. Taking CE classes online have been easier for him.



- -Chico shared from a parent perspective. Echoed what was said about teachers. Parents understand the lift being done. Sympathetic when things like technology are down, etc. Improvements being made every week. So appreciative. There are no perfect solutions.
- -Jenise shared from a technical college perspective that it has been especially challenging for a hands-on learning environment. But Pickens has been fortunate to have students oncampus since several programs were deemed essential by governor. Instructors are being careful and rotating small cohorts of students. Working well.

Michelle invited Mark Thompson from Pagosa Springs to share his experience of being a grantee so far. Mark shared how happy they are to have the grant. Six teachers are working on completing their graduate credits from last year and two new teachers are starting their programs. Out of 24 teachers, 8 of them are getting their Master's paid for, which leads to more CE courses for students. It is a big deal for his little school.

Michelle shared there will be a supplemental grant offered to Cohort I as the smaller number of applicants this year allowed for more funds being available.

20-21 CE grant is currently paused. Awaiting status of state budget.

• ASCENT- Andy Tucker

Andy shared due to budget constraints from COVID, state agencies were asked to look at savings. At one point, ASCENT slots were being considered to be cut in half. That did not occur however, it is recommended that CEAB look at potential updates to the allocation model to be prepared for any scenarios where slots might be decreased.

Andy presented the current allocation model as a review. Following is a snapshot from the <u>ASCENT website</u>:

ASCENT Allocation Model

The Concurrent Enrollment Advisory Board developed a system to equitably allocate ASCENT slots to local education providers (LEP) in the event that the number of qualified students exceeds the number of funded slots:

Currently participating LEPs will receive a minimum number of ASCENT slots equal to those utilized by students during the current school year.

- New LEPs will receive up to 10 slots for the first year or the number requested if less than 10
- If additional spaces are available, half the remaining slots will be distributed via the LEPs free and reduced lunch (FRL) rate as a proration
- The other half of remaining slots will be proportionally distributed based on LEP size, to LEPs that did not receive spaces under the FRL distribution
- Unused slots may be returned to the general pool and reallocated to LEPs

The question is: Does CEAB want to reconsider the ASCENT allocation model or wait and see what the budget ends up looking like. Sarah acknowledged the effort it takes to market ASCENT at schools and building a student pipeline. Mary recommended a stronger focus on students and families who do not qualify for PELL or any financial aid. Someone asked if there are eligibility guidelines from the state on a family's income for ASCENT. Per Andy, those can be made by the district but there are no statutory guidelines on that.



Sarah made a motion for a subcommittee to look at the model in-depth and report back to the board. Dahle seconded. Ayes.

COSLI

Student summer leadership program. HS sophomores/juniors encouraged to apply. Month-long, 3 college credits, experiential activities. Hosted at CU-Denver.

• Free Application Day

On Oct 13th. Extremely successful. Admissions directors were being cautiously optimistic. Were not sure how many to expect. Over 12,000 from last year. Promising news of students' intent to enroll next year. 56,000 applications total (students can apply to more than one institution).

Question: Can transfer students take advantage? Per Carl, yes. (Not graduate students).

Question: Who should a student contact if they had issues? Per Carl, contact the institution. Colleges have been flexible with this.

CE/Dual Enrollment Webinar

Hosting a town hall/discussion on Oct. 29th. There are still a lot of questions on what is and what is not CE. Plan to go through the CE Checklist and open it up for questions on each requirement. Goal is to create clarity.

COVID-19

Institutions who had outbreaks off-campus initially are doing a good job at testing and enforcement. They are doing a good job of keeping students, faculty and staff safe.
