THE DIRECTOR'S CORNER

There has been much discussion and controversy about the corporate training commonly referred to as the ALICE Training – Run, Hide, and Fight – as well as adaptations of these directions. The 2013 *Guide for Developing High-Quality School Emergency Operations Plans* written in cooperation by the U.S. Departments of Education, Health and Human Services, Homeland Security, and Justice, along with the FBI and FEMA includes these directions on pages 64 and 65 for staff. I think we all recognize that not everyone in a school setting would be able to follow any or all of these directions when confronted by an active shooter.

The National Association of School Psychologists (NASP) has recognized the complexity of instructing school personnel to take these actions and is working in cooperation with the National Association for School Safety and Law Enforcement Officers (NASSLEO) to review these instructions.

I will keep you updated on those discussions. In the meantime, we hope that all schools are practicing the universal emergency responses - no matter what you call them: evacuation, shelter in place, lockdown, lockout and reunification. Discussions about staff options if they ever come face to face with an active shooter should also be a part of those trainings. Stay safe! Chris
