Requirements

- ✓ Be sixteen (16) years of age
- ✓ Reside in Colorado at the time of the application and possess a Colorado mailing address
- ✓ Register online at www.ged123.org. This process will take about 20 minutes. If you do not have access to the internet, please be sure to check the box below stating so. You will register at the test center upon approval.
NOTE: If you are testing via computer, you **do not** need to register at GED 123.
- ✓ To apply, fill out this application, provide a support letter for the condition for which you are applying and include the \$5 fee (check or money order) made payable to "CDE/GED Testing Program".

- ☐ Applicant has been expelled from school or denied admission in accordance with the provisions of C.R.S. 22-33-104.
- ☐ Applicant is enrolled in a "Pilot School" that has entered into an agreement with a school district or board of cooperative services to provide educational services enabling the applicant to successfully complete the GED.
- ☐ Applicant has a probation condition requiring the attendance of an educational program or to work toward the attainment of a high school diploma or GED.
- ☐ Applicant has a parole condition requiring the attendance at an educational program or to work toward the attainment of a high school diploma or GED.
- ☐ Applicant is subject to the jurisdiction of the juvenile court.
