We have so many good things happening over the course of the upcoming school year! The following resources and activities are not exclusive to all that may be happening across the state in supporting children and youth with blindness/visual impairment, their families, and service providers. If there is a resource or activity that was missed on this list, please be in touch with Tanni to post it in future editions of the newsletter. Our communications are greatly improved when we work together to make announcements, have celebrations, and share resources.

A Shared Vision: This 501(c)(3) nonprofit organization is Colorado's leading provider of early intervention vision services for children who are blind or visually impaired. Their goal is that all families of children with visual impairments have access to and receive essential early intervention services from a community of highly skilled and collaborative professionals. We support three programs. Through the Early Intervention Vision Services program, the team of 15 EI-TVIs provide direct early intervention home-based vision services to families and young children, birth to age three, in 55 counties across Colorado. The services are defined by the families' Individualized Family Service Plans (IFSP) developed in conjunction with A Shared Vision, Community Center Board service coordinators, and other early intervention providers. This program supports the key principles and evidence-based best practices of early intervention in Colorado by providing education and empowerment to families with young children who are blind or visually impaired in their homes and in community settings.

In 2022, A Shared Vision supported 212 children, providing 1,675 educational service visits. A Shared Vision provided 61.4% of all early intervention vision services to families statewide. Through their Family Support Program, A Shared Vision provides education, community connections, and support for families of children with visual impairments through in-person and virtual group activities, the newsletter, website resources, and other communications. EI-TVI Kimala Rein from Grand Junction has led our "Mystery Parties" for families since last year. The one-hour virtual format features topics such as how to support their child's sleep to a craft activity the family can do with their child. This July, EI-TVI Maggie Tutt joined Kimala as they showed families how to make a sensory cube and demonstrated how playing with it develops tactile, language, and orientation and mobility skills. Finally, A Shared Vision's Education Program builds the community of highly skilled and collaborative professionals who serve infants and toddlers with blindness/visual impairments. In July 2022, A Shared Vision was awarded the contract from Early Intervention Colorado to update the state's vision screening protocol as we return to in-person evaluations. The updated protocol supports EI evaluations conducted in person, via telehealth, as well as a hybrid approach. Nearly 400 EI evaluators, Community

Anchor Center for Blind Children: Anchor Center for Blind Children: Headquartered in Denver for 40 years, Anchor Center for Blind Children specializes in serving children with visual impairments or combined vision and hearing loss during their most formative years of development, ages birth to five years. Staffed by a transdisciplinary team of highly trained teachers of students with visual impairments, early childhood special educators, therapists, and a pediatric ophthalmologist, Anchor Center's vision services are customized to meet each child's unique needs and strengths. Families also receive support, guidance, practical knowledge, and connections to other important resources. Anchor Center's primary programming includes: vision assessments and pediatric ophthalmology exams; early intervention home-based services (for children, ages birth to 3 years); center-based programming for infants (newborn – 18 months), toddlers (18 months – 3 years), and preschoolers (3 – 5 years); occupational, physical, and speech/language therapies; recreational, music, and horticultural therapies; summer camps and family respite care; and family support, including programs for caregivers and siblings. Anchor Center charges a nominal tuition fee for toddler and preschool programs but does not charge for infant services. No child is ever denied access to services based on the family's inability to pay. In the 2022-23 school year, Anchor Center served 400 children, caregivers and siblings in home and community-based settings, and at their state-of-the-art facility in the Central Park neighborhood, located at: 2550 Roslyn Street, Denver, CO 80238. Audio Information Network of Colorado: Audio Information Network of Colorado (AINC) started providing audio editions of publications to individuals needing an alternative to print in 1991. Volunteers continue to read these publications. Four original podcasts are now part of AINC's offerings. The Aftersight podcast is a weekly interview program with guests who are blind or have low vision. It usually ranks in our top five programs. Blindsight is dedicated to the healing of the mind, body, and soul. Bill Lundgren and guests address mental health, trauma, and relationships. Navigating Life with Vision Loss covers a different topic each month giving a voice to the challenges facing people with blindness or vision loss. Blind Level Tech is our newest offering. Evan and Jonathan discuss adaptive technology, both traditional and cutting edge. It is quickly becoming one of AINC's most popular shows. These podcasts are available on all the primary podcast platforms as well as the AINC website. All the new programming is based on input from our Programming Advisory Committee, now in its second year.

AINC provides services beyond our audio programming. The White Cane Project provides free fiberglass folding canes with the standard red/white/black coloration. This initiative is funded by the Colorado Lions Clubs. Other new offerings include a weekly virtual peer support group and a monthly virtual audio book club. **Braille and Large Print Format Colorado Measures of Academic Success (CMAS) Test Review:** TVIs have the opportunity to meet with the CDE Unit of Student Assessment and the CMAS publisher to review braille CMAS tests. There will be continued work specific to these assessments and educators are always needed. **Colorado Administrative Units**: The term "administrative Unit" (AU) means a school district, board of cooperative services, or the State Charter School Institute, which is providing educational services to exceptional children and is responsible for the local administration of the Exceptional Children Education Act. For purposes of the education of school age (ages three through 21 years) children with visual impairment, including blindness, an administrative unit can be the family's local school district, as well as the Colorado School for the Deaf and the Blind. The vast majority (over 90%) of school-age students with visual impairments, including blindness are served in their neighborhood school district with a locally hired TVI and/or O&M Specialist. Some administrative units may use contract services for their TVI and/or Orientation and Mobility services. For questions about main contact personnel for students with visual

**CAER - Colorado Chapter of AER:** As professionals who serve the community of individuals who are blind/visually impaired, we have an active Colorado chapter of our national Association for Education and Rehabilitation of the Blind and Visually Impaired (CAER for short!) professional organization. **CAER Mini Grants:** CAER provides mini grants to current AER members or those sponsored by an AER member. The maximum amount of the funds available will vary, but the allotted amount per grant must not exceed \$300. Recipients are only eligible to receive a mini grant once every two years. Recipients need to fulfill their obligation to provide CAER with an agreed-upon presentation of how the mini-grant funds were used within 90 days of check issue. Applications are accepted throughout the year and are due November 1<sup>st</sup> for review.

**CAER Reimbursement for ACVREP Certification:** Reimbursement for initial (\$100) and renewal (\$50) certification through ACVREP may be available to CO AER members. After receiving your initial and/or renewal, please submit a copy of the certification and letter requesting reimbursement to CAER at <u>caerboard@gmail.com</u> To apply, you must provide proof of AER membership.

**Colorado Department of Education (CDE) Braille Competency Certification:** Funds have been reserved for four braille proctors (Nancy Cozart, Chris Maynard, Brenda Shepard, and Julie Wetzstein) to provide opportunities for TVIs / braillists to take the Colorado Braille Competency Test and/or the 15+ clock-hours of CDE established renewal modules. Care must be taken to spread out the completion of the modules over the five-year-renewal period so that competency can be truly demonstrated across a period of five years. **Colorado Center for the Blind Youth Programs:** The Colorado Center for the Blind has brought high-quality, welcoming, and yet challenging programs and training for youth ages 4 to college since 1990. Whether it's CCB's year-round Fun Activities and Skills Training (FAST) program, mentoring for students attending the Colorado School for the Deaf and the Blind (CSDB), Confidence BELL Academy, residential summer programs for teens, or collaborating with partners such as Cyber.org for CCB's first coding and robotics camp, CCB is committed to creating opportunities that raise expectations for blind students and help them build the confidence to pursue their dreams as successful adults.

At the beginning of the summer, CCB collaborated with the company cyber.org to introduce blind students in the Denver-Metro area to the exciting world of coding. Students aged 11-15 were able to demonstrate some skill in

technology, coding and programming a Microbit, an open-source hardware ARM embedded system. Students were even able to code their devices to say their names with a healthy competition to see whose device would have the most intelligible speech. Of course, after using all of that brainpower, all of the participants and a few positive blind role models traveled to the Gravel Pond at Chatfield State Park for some refreshing time kayaking and ensuring everyone got wet.

During the month of June, the Colorado Center for the Blind also had their annual 2-week BELL Confidence Camp for elementary aged students. The theme of this year's camp was transportation. Students took the bus to the grocery store for a practical shopping experience and took the light rail and train to Denver International airport for an interactive tour and presentation from airport and airline staff. The young participants improved Braille Literacy skills, challenged themselves with rock climbing and other challenge recreational activities, and made themselves lunch in the center's training kitchen. In July, CCB hosted 15 teenagers from across the country and abroad in the four-week No Limits to Learning program, and seven outstanding summer counselors working with them. While learning Braille, accessible technology, cooking, cleaning, and cane travel skills, They also had the opportunity to go rock climbing, kayaking, visit the Fiske Planetarium on the CU-Boulder campus and much more! On Saturday, September 16, CCB's fun activities and skills training will return at the Carson Nature Center in Littleton. Participants will be able to play some fun games, interact with live animals, and experience the natural environment within South Platte Park.

**Colorado School for the Deaf and the Blind (CSDB)**: The Colorado School for the Deaf and the Blind is a state funded school within the Colorado Department of Education. The school was established for the purpose of providing comprehensive educational services for children, birth to age 21, who are blind/visually impaired and/or deaf/hard of hearing. Services are provided directly to students enrolled at the school, and outreach programs service students, staff, and families in communities throughout Colorado. There is no tuition charge for students to attend CSDB, which is located in Colorado Springs; however, there is a charge to districts receiving outreach services. CSDB is required to follow all state-education laws that apply to other public-school programs. Parents may choose to enroll their child with blindness/visual impairment after conversation about placement with their school district Special Education

**CSDB Cane Quest:** Cane Quest is a challenging orientation and mobility contest for students in grades 3-6. Scout contestants team up with older students and earn coins as they compete in various challenges that demonstrate mastery of basic orientation and mobility skills. CSDB sponsors an annual event. Stay tuned for more details on if this event will occur during the 2023-2024 school year.

**CSDB Lending Library**: The library provides materials and information in a variety of formats for students who are deaf/ hard of hearing and/or blind/visually impaired, as well as their parents and service providers. **CSDB and CSDB Outreach National Braille Challenge:** The Colorado regional contests will again be held at CSDB and the Colorado Center for the Blind during the 2023-2024 school year. Students may also compete individually in their home school with their TVI administering the tests. Students compete in various categories such as spelling, reading comprehension, speed and accuracy, proofreading, and charts and graphs. The Braille Challenge will be held on the campus of CSDB on February 22, 2024. The contact for the CSDB day is Jamie Lugo at jlugo@csdb.org. CSDB Outreach will co-host the Braille Challenge at the Colorado Center for the Blind, which will be held on February 23, 2023. **CSDB Specialized Assessments and Consultation:** Specialized assessments; for example, functional vision, learning media, O&M, cognitive and social-emotional, may be provided to school districts, BOCES and charter schools to assist school staff in developing appropriate educational services and supports for students with vision losses. **CSDB Role Model Videos:** The CSDB Role Model Videos are designed to provide students who are blind or visually impaired, their parents, and teachers the opportunity to understand life experiences of successful adult role models who are blind and visually impaired. **Colorado Services for Children and Youth with Combined Vision and Hearing Loss Project (also called the Colorado Deaf-Blind Project:** We are finishing the last months of our current five-year cycle. A new five-year cycle will begin on October 1, 2023 with an increase in funding. There are currently <u>154</u> children and youth, age birth through 21 years, who have combined vision and hearing loss (deafblindness) in Colorado. Key activities include:

- · Annual Child Count of Colorado children and youth with deaf-blindness
- Free technical assistance is provided to the families and service providers of children and youth with deafblindness
- · Training and coaching for school-based interveners.
- · Annual Webinar Series
- · Annual Family Conference for parents and key caregivers.
- Annual Summer Institute, which focuses key assessment of and intervention / instructional strategies for children and youth who are deaf-blind
- · deafblind and/or who have significant support needs.
- Website with over 100 fact sheets (in English and Spanish) on information specific to deaf-blindness.

**Community Intervener Program:** Family Voices Colorado is proud to be handing the Community Intervener Program over to the Colorado Commission for the Deaf, Hard of Hearing, and DeafBlind starting in October. The project offers Colorado children and youth 10 hours a month of 1:1 services with a professional intervener in their home and out enjoying their communities in ways they have not been able to participate before. **Eligibility – Deaf-Blindness**: The determination of whether a school-age (ages three to 21 years) child meets the eligibility criteria as a "child with deaf-blindness" is the responsibility of the local administrative unit's Individualized Education Program (IEP) team, which includes the child's parents, and is based on state approved eligibility criteria. For children who are entering the public-school district from an early intervention program or a private early childhood program, eligibility for school-based special education services and supports is not determined by personnel associated with these early-years programs. It is critical that parents are given accurate information about the eligibility process with school district staff. It is the IEP team who will further determine the need for an intervener. **Eligibility – Visual Impairment, Including Blindness**: The determination of whether a school-age child meets the eligibility criteria as a "child with visual impairment, including blindness" is the responsibility of the local administrative unit's Individualized Education Program (IEP) team, which includes the child's parents, and is based on state approved eligibility criteria. For children who are entering the public-school district from an early intervention program or a private early childhood program, eligibility for school-based special education services and supports is not determined by personnel associated with the early intervention / private early childhood programs. It is critical that parents are given accurate information about the eligibility process with administrative unit staff. **Foresight Adventure Guides for the Blind:** Foresight provides goal-oriented outdoor adaptive recreation experiences for students with low vision and blindness. Students have two opportunities to participate in Foresight's fun, safe and transformative programs. The Winter Learn to Ski/Snowboard program and the *Summer Camp for Blind Youth*. Both programs use outdoor recreation to promote self-confidence, independence, and personal growth for students who are blind or experiencing low vision. Each winter, students from a half dozen Colorado school districts plus Colorado School for the Deaf and the Blind travel to Vail with teacher chaperones for two days of skiing/snowboarding. Returning students who have mastered basic skiing/snowboarding skills are paired with a Foresight guide and shadow to practice their skills and explore Vail's varied terrain. Students new to the sport receive professional ski or snowboard instruction from Vail's Adaptive Ski School. All the students experience the joy and freedom of skiing blind! Foresight provides the students with roundtrip transportation to Vail, lift tickets, ski or snowboard equipment, professional

instruction (if needed), two days of lunch, and one-night lodging, for a requested minimum donation of \$75. However, Foresight will not turn any student away if they cannot pay the suggested donation.

Foresight's *Summer Camp for Blind Youth* offers students three days and two nights of fun outdoor experiences in the Vail Valley. Campers participate in stand-up paddle boarding, horseback riding, rock climbing, hiking and more. Team building and leadership activities are also incorporated into the camp. Foresight provides two nights lodging, lunch daily, one dinner, and all activities for a requested minimum donation of \$100. Again, students will not be turned away if they cannot pay. Camps take place in mid-June and mid-July. Both the Learn to Ski program and summer camps promote components of the National Federation for the Blind's Expanded Core Curriculum. Foresight's programs reinforce elements such as socialization, self-determination, orientation and mobility, independent living skills, and of course sports/recreation skills development. Participants also report developing close friendships with people "just like them." Send your students to Vail to learn important life skills all while mastering activities they can safely enjoy with friends and family throughout their lives. **READ Act:** The CO Reading to Ensure Academic Development Act (READ Act), passed by the legislature in 2012 and focuses on literacy development for all students and especially for those at risk to not read at grade level by the end of the third grade. The READ Act focuses on literacy development for kindergarteners through third-graders. Students are evaluated for reading skills, and those who are not reading at grade level are given individual READ Plans. TVIs should collaborate closely with general educators / literacy specialists on the READ Act screening, and if needed, diagnostic procedures to assure accessibility. This may include preparing materials in braille, utilizing commercial screening tools in braille format, assisting with magnification and other low vision needs of the visual presentation of the screening / assessment materials. The TVI may provide consultation to assist with the interpretation of results on timed screening / assessment procedures for learners using braille materials where normed testing was based on print readers.

<u>See the Future 'Tools for Life' Program</u>: Providing financial assistance to the families of students who are blind/visually impaired (PreK – Transition) who are residents of Colorado. This assistance is to help purchase necessary adaptive equipment, which students may own and use in their home, school, and community. **See the Future Education for Life Program is** pleased to award scholarships to qualified Colorado students who are blind/visually impaired. This scholarship fund is made possible through generous donations by optometrists, ophthal-mologists, educators, opticians, technicians, corporations, foundations, and many others with an interest in the lives of these learners. This program provides scholarships to support Certificate Programs such as massage therapy, Associate's 2 year degree, BA degree, MA degree, or a doctoral degree. **UEB Technical versus Nemeth Code:** The Braille Authority of North America has recognized both UEB Technical and the Nemeth Codes as approved braille math codes. As such, the decision of which code will be used for a child who is a beginner through an advanced braille reader is determined by the local Individual Education Program team. Textbooks can be ordered in both codes, the CMAS State Assessments are offered in both codes, and there are procedures to order College Board tests in either code.

**University of Northern Colorado VI Program**: The University of Northern Colorado offers an Online Master of Arts Degree Program / Visual Impairment. This program provides teacher candidates with the skills and knowledge to help students with visual impairments meet their potential in academic and social areas of their lives and prepares teachers-in-training to work with students from birth to age 21 with a special emphasis on the needs of early childhood and elementary-aged students. - **Roberta Curtis** is a Program Support Assistant with the Exceptional Student Services Unit. In this capacity she supports our CO DB Project and the BVI activities of Tanni Anthony. Roberta has personal experience with the LVE Clinic as a parent and has graciously agreed to take on the role of LVE Clinic State Coordinator.
- **Dr. Kara Hanson** is an associate professor of ophthalmology at the University of Colorado and Director of the Low Vision Rehabilitation Service at the UCH-Sue Anschutz-Rodgers Eye Center. She also provides low vision evaluations for preschoolers at Anchor Center for Blind Children. She graduated with her Doctor of Optometry degree from the University of Houston College of Optometry and was on faculty there before moving to Colorado in 2005. She has been a long time friend to students with blindness/visual impairments, their families, and providers.
- Karin Hensel has been teaching for 21 years, initially as a classroom teacher in middle and elementary school, and as a certified Teacher of Students with Visual Impairment (TVI) since 2006. Karin earned the Certified Orientation & Mobility Specialist (COMS) and Certified Low Vision Therapist (CLVT) certifications in 2011 through the University of Arizona. Since moving to Colorado in 2011, Karin has worked as a TVI/COMS for students 3 to 21 years of age; served on the ACVREP CLVT Subject Matter Committee in 2021 and 2022; and coordinated the Denver Metro Low Vision Evaluation Clinics for the past two years. She earned a Master in Teaching degree from Sierra Nevada College; completed the graduate program at University of Arizona to specialize in Visual Impairments; and completed the UNC's Director of Special Education credential program.
- Jim Olson is a TVI, COMS, and Certified Low Vision Therapist. In his current role as the CIMC Coordinator, Jim understands how many Colorado learners with low vision can benefit from magnification tools. # **Colorado Deaf-Blind Project News**

**Project Purpose and Staff:** The Colorado Services for Children and Youth with Combined Vision and Hearing Loss Project (aka the Colorado Deaf-Blind Grant) is in the final year of its federally-funded five-year grant cycle. The purpose of the project, awarded to every state and US territories is to identify children and youth with deaf-blindness and provide free technical assistance (TA) to the identified children, their families, and service providers. We started the current grant award on October 15, 2018, and it will be completed on October 14, 2023. The project has been housed within the Colorado Department of Education's Exceptional Student

COLORADO Assistance for those SERVICES FOR with combined vision CHILDREN WITH and hearing loss DEAF-BLINDNESS

Services Unit for over 30 years. The team worked tirelessly to prepare a new grant proposal that was submitted several days ahead of the March 13th deadline. The grant has been awarded for another five years and our review ratings were 98 out of 100! So we are off and running again as of October 1, 2023!

Key project activities are to maintain an annual Child Count process, host professional learning events, and provide tiered and customized technical assistance. The current project has three broad goals: (1) timely identification, (2) family networking, training, and TA support, and (3) professional training and TA support, and 4) intervener recruitment and training / support. The project has an active website, lending library, and Deaf-Blind Advisory Task Force. We have five CDE employees (**Tanni Anthony, Gina Herrera, Roberta Curtis, Jessica Meisel,** and **Wendy Stoltman**) and our contracted Family Engagement Specialist (**Cindy Colwell**) on board with the project. ## The Peer Viewer's Role in Producing Quality Writing

As a young child, you may have heard the word "peer" used to describe the act of looking at the world around you with careful attention. You eventually learned that "peer" could also mean a person whose age, experience, and knowledge are similar to yours. Perhaps you were in college when you first heard "peer review" used to describe the process of considering and preparing material for publication.

As a professional, you recognize the role of the peer review process in enabling editors to decide which material will be most useful to readers. Peer reviewers are experienced professionals who volunteer to assist in selecting the most promising articles for a journal's reading audience. Reviewer feedback helps maintain high quality and consistency.

The New RE:view (TNR) publishes peer-reviewed articles that have been carefully evaluated by professionals who work with people with visual impairments. Reviewers are selected because they have knowledge and experience related to the submitted article. They provide constructive feedback about style and content. Ultimately, reviewers recommend whether an article should be published, needs changes, or is not appropriate for publication.

A returned manuscript rarely meets the authors' highest hopes or fulfills their deepest trepidations. The author will read carefully to understand the perspectives and perspectives of the reviewers. A successful revision requires time and thought to address concerns of the reviewers, and usually leads to publication.

TNR continues to seek peer reviewers who can provide a practical review of articles that are submitted for consideration. We appreciate the work of professionals who regularly serve as reviewers. We are especially interested in professionals who have expertise in specialized skill areas. When working with children, teachers strive to make their classroom a fun and engaging place of learning.

So many classroom theme sets have fun colors, bright designs, and patterns, contrasting bulletin board borders, etc. designed to do just that.

Many believe that having a colorful classroom will keep children interested and engaged, and the themes and coordinating colors CAN definitely be used...but...

Visual Noise is just that: a visually distracting, or "noisy" visual scene in the classroom. A lot of teachers set up bulletin boards throughout the room with cut-outs in various themes: animal/monster/any theme, alphabet stickers, and painted murals on the walls.

Maybe your classroom has a circle time rug that includes the ten different color squares.

Perhaps you want to make sure all the children have something they like to do, so you have 20 fine motor choices in the manipulative area.

There is just one problem with using these types of visuals in the classroom, they are distracting!

Classroom décor and organization can directly effect the engagement level of children in any classroom or learning space. When the environment is too visually stimulating, a student's ability to focus becomes difficult





# **Initial CDE Braille Competency Testing Requirements**

**Initial CDE Braille Competency Certificate**: All licensed teachers endorsed in the area of visual impairment, including those individuals employed on a temporary status (Temporary Educator Eligibility-TEE), who are completing their university program in visual impairment, must have a valid CDE Certificate of Braille Competency or a CDE Renewal Certificate of Braille Competency on file with their current administrative unit of employment. The CDE Certificate of Braille Competency must be earned <u>no later</u> than May 31st of the first instructional year as a teacher of students with visual impairments, with a Colorado administrative unit. If a TVI moves from one Colorado administrative unit to another, the expectation of first-year braille competency demonstration does not "reactivate" from year-to-year. The testing clock begins with the first day of Colorado employment as a TVI.

The initial CDE Braille Competency Certificate expires fives years from its date of issue.

# **Renewal CDE Braille Competency Certificate**

There is a one time expectation to renew the initial CDE certificate five years after its initial issue. This is accomplished by completing 15 renewal modules across the five year renewal period. These modules must be taken with one of the CDE Braille Proctors.

**Can a non-educator nominate an educator and/or project?** No. Funding through this partnership is intended to address the individual and specific need(s) of each educator and classroom. 

# Visual Impairment, including Blindness

Thank you to all of people who took time to discuss, craft, and comment on the updated eligibility criteria of Visual Impairment, Including Blindness. Thank you also to the Colorado State Board of Education for their careful view and constructive feedback on the draft version and the ultimate final version, which is effective as of June 2023.

The updated eligibility criteria can be found in the <u>Rules for Administration of the Exceptional Children</u> <u>Education Act.</u>

2.08(11) A child with a Visual Impairment, Including Blindness has an impairment in vision that, even with correction, adversely affects the child's educational performance and that requires specialized instruction. The term includes low vision, blindness and/or progressive vision loss.

2.08(11)(a) A determination that a child is an eligible child with a Visual Impairment, Including Blindness may include but not be limited to:

2.08(11)(a)(i) Visual acuity of no better than 20/70 in the better eye after correction;

2.08(11)(a)(ii) Visual field restriction to 20 degrees or less; and/or

2.08(11)(a)(iii) A physical condition of visual system which cannot be medically corrected and, as such, affects visual functioning to the extent that specially designed instruction is needed.

These criteria are reserved for special situations such as, but not restricted to cortical visual impairment and/or a progressive visual loss where field and/or acuity deficits alone may not meet the aforementioned criteria.

Tanni will be working with the Vision Coalition and internal CDE personnel to finalize training guidance. As with all eligibility categories, it is necessary to (a) define the vision impairment from an eye report that details diagnosis, prognosis, and clinical visual functioning ; (b) determine the educational impact based on educational evaluation; and (c) confirm the need for specially designed instruction.

#### **UEB Technical Versus Nemeth Braille Codes**

The Colorado Department of Education does not dictate a math code for students with visual impairment, including blindness. Two math codes are approved by the Braille Authority of North America. The decision about the math code is an individual student-by-student or an IEP decision. Both codes are viable for instruction and state testing. #### BANA's position on UEB and Nemeth

**This is still relevant:** As a result of lengthy and in-depth discussions over several days in November 2015, the BANA Board members representing United States organizations approved the following statement regarding braille math and technical materials as it relates to the adoption of UEB in the United States.

The Braille Authority of North America (BANA) recognizes and appreciates the genuine concerns from the braille community regarding the transition to Unified English Braille (UEB). BANA stands by our original motion to adopt UEB as a complete code as well as the implementation statement issued in 2014 in which we expressed that the Nemeth Code remains integral to braille in the United States. The Board of BANA could not reach consensus regarding the establishment of a single standard code for technical materials for braille in the United States. **The decision to use UEB or the Nemeth Code within UEB context for technical materials should be made based on braille readers' individual needs.**

#### **Current Key Points**

- There is no default math code. The code that is used by individual children can be either UEB or Nemeth.
- Every other country that has adopted UEB is using ONLY UEB for all materials and has ceased to use Nemeth including Canada and New Zealand, or whatever their former math code was (which includes Australia, Ireland, the UK, and South Africa. Students in those countries continue to major in math and science, do <u>all</u> their work in UEB, and are go on to college. UEB is structured differently than Nemeth but it's perfectly capable of doing math and science at all levels.
- Since UEB contains symbols for all the math symbols, kids will see symbols such as the degree sign, percent sign, signs of operation and comparison etc. in all kinds of materials—cookbooks, weather reports, news reports that include stats, etc. In other words, kids will be learning all those symbols in UEB anyway . . . so the contention that learning these symbols is "added work" is also not correct.


