STATE BOARD OF EDUCATION LEARNS FROM STUDENTS IN FOUNTAIN-FT. CARSON

In a meeting with students on the evening of February 7, 2004, the State Board learned that Fountain-Ft. Carson High School's uniqueness spans far beyond no lockers in the school and few enclosed classrooms. Fountain-Ft. Carson High School is one of ten schools in the district led by Superintendent Dwight Jones, who along with his predecessor, Dale Gasser, effectively led the district into closing their achievement gap entirely and raising their graduation rate to 98 percent. For a district with a high rate of mobility, and students with backgrounds of 45% low income and 40% minority, this is no small feat.

The State Board of Education wanted to meet with the students in the district to learn their perspective on what rigorous standards, greater expectations and student achievement for all means to them. Some of the changes the district implemented were: 1) Increased length of the school year with added summer programs and school-year tutoring programs; 2) New graduation requirements that exceed

CCHE's newly adopted college admission standards – four years of math, science, language arts and social studies; 3) Revamped school day with an emphasis on literacy; and 4) Strategies to recruit, retain and train teachers. Additionally, to help at-risk students, the district offered personal counseling and parental outreach. To encourage high-achieving students, the district added advanced placement and college-level courses.

According to the students, the standards set by the district were not only attainable, but many had surpassed them and had already acquired two years worth of college credit as high school seniors. The State Board was also surprised to learn that the students had very little homework on average and were able to complete most of their work within their block schedules.

Principal James Calhoun led the Board on a tour of this very impressive school through the multiple computer pods and their state-of-theart auditorium. The Board would like to extend their gratitude to the students and administrators in the school and district for taking their time on a Saturday evening in what was a valuable lesson from those that matter – the students.
