COLUMBINE REMEMBERED

April 20, 1999 11:30 a.m. By Clair Orr

As chairman of the State Board I was on a routine call with Commissioner Bill Moloney when he said after an eerie silence, "I just received a note that there has been a shooting at Columbine High School." Little did anyone outside the school know the extent of the evil acts being committed that sunny morning in April.

By 12:30 p.m., as the story unfolded, the bright sun was at high noon but there was an ominous cloud building with a sinister appearance. As students rushed to flee the horror that would brand their memory forever, swat teams moved in like a scene from a bloody action movie. The news crews catching every movement and reporting every detail.

By late afternoon, I had talked to the Commissioner again only to learn that

fellow board member Randy DeHoff's daughter, a student at Columbine, had not been heard from. That dark cloud was not just over Columbine now, it had begun to spread across the Columbine State as the sinister acts of two demented young men were affecting the lives of thousands across our state and nation. When I called Randy around 6 p.m. inquiring about his daughter's safety, he had just received word that she was on her way to the library when a hand reached out from behind a door and pulled her into a room to safety. An untold miracle in the midst of all the death.

I don't remember seeing the setting sun that day. It must have been blocked out by a cloud of brutality spilling innocent blood from the senseless acts of two minds self-destructing, bent on spreading destruction. The evil that had captured the shooters' minds was fulfilling the devious plan they had replayed over and over.

We will never know if they could have been rescued from this fate had the early warning signs of their tormented minds been taken seriously. We will also never know how many students are living today because similar warning signs were taken seriously.

The following morning the sun rose but it did little to answer the questions or warm the soul as the magnitude and reality of the tragedy unfolded. In praying, like thousands of others, for the families who suffered untold loss, I was also praying for direction as to what I should be doing as chairman to lead our board in the wake of such a tragedy.

I called an emergency meeting of the State Board not knowing for sure what we could do but that we had to do something. A conference call was arranged and all board members participated: Pat Chlouber, Gully Stanford, Ben Alexander, Randy DeHoff, John Burnett, Patti Johnson and myself. Also included were the Commissioner and Lynn Fontanier (the Director of State Board Relations). After hearing the latest update from the Commissioner, I asked the Board to share their thoughts regarding this tragedy. The meeting was intense and sobering as every board member spoke from their hearts. The Commissioner was taking notes to capture the Board's best thinking at a time of our state's worst nightmare.

We decided to produce a statement from the Board, in an effort to look beyond these dark hours to a light guiding us out of this current darkness.

The statement would be a catalyst for change showing that Colorado is still the backbone of the nation, like our Rocky Mountains, and affirming that the forces of evil will not prevail. We can and will remember the fallen and resurrect the spirit and the decency that made Colorado a great place to live and raise a family.
