# Board Actions – January 8, 2004 Department of Education, Denver

A Message from the Chairman

It is an important time to be involved in public education policy in Colorado and the United States. As the new chairman of the State Board of Education, I am looking forward to 2004 as a time when we take effective approaches to improve quality education for all students in this state.

The State Board of Education plays a crucial role in setting state policies and rules that affect every element of a strong public education system, including licensing, transportation, nutrition, and preschool. The Board also makes budget recommendations to the legislature and governor. Each State Board member is sincerely committed to student learning and good results, and we

work together as a board to reach these

As we begin a new year, I look forward to working with my colleagues on the board to update the State Board's Strategic Plan that will guide our actions. Throughout the year State Board decisions are enriched by input from local and state policymakers, school and district leaders and staff, the dedicated staff of the Colorado Department of Education (CDE), and members of the community.

Colorado faces many issues that have an impact on how well our students learn so they can succeed in life, enroll in higher education, participate in the economy, and contribute to society through civic and community involvement, service to our government, arts, science and health, familybuilding activities, or innovative private ventures. Our state has had major successes in producing good national test scores in

some areas, yet at the same time we have continuing concerns about some schools' performance on state assessments, an achievement gap among low-income and minority students, low graduation rates among high school students, and low support for special education funding. While the state has made improvements in some of these areas, we have more work to do.

We must continue to support our districts and schools by providing adequate funding. even as our state faces fiscal restraints and revenue and spending limitations. Sufficient funding is integral for districts' and schools' success, including their ability to meet state and federal accountability measures, such as accreditation, perform well on the Colorado Student Assessment Program (CSAP) and School Accountability Reports (SAR), and make Adequate Yearly Progress (AYP). State policies that provide for thoughtful state model content standards, high quality teachers, early childhood education, parent education, and quality choices in our public school system will increase our positive results. How well the state provides for good quality public school choices for our children and families, including charter schools, contract schools, online schools, and open enrollment, is also important to a successful outcome. We need to consider our districts and schools when we make decisions about choice.

This state's policy decisions on education accountability over the past decade have helped the state understand if students experience a quality education. School

districts have partnered with the state in a positive way to reach this common goal to help students learn. Colorado's respect for local control in instructional, curriculum, and standard-based decisions has produced a wide range of innovative local approaches. It is clear that our districts and schools offer students a lot of knowledge and skills, while striving to provide a comprehensive, well-rounded educational experience that includes transportation, health and nutrition, and special education.

Central to a thriving state education system are the state model content standards, which guide districts and schools through a process designed to produce good learning results. The standards, which cover content in 13 subject areas, shape the CSAP and accreditation, and provide content guidelines for districts to consider. The State Board of Education will discuss the process to update these standards as part of our annual strategic planning sessions.

As Colorado joins the other states in the nation in implementing accountability requirements in the federal No Child Left Behind law, state education policymakers will focus on how best to make this and state accountability requirements meaningful to parents, students, educators, and administrators. Education policymakers at all levels face many challenges and opportunities to support learning, and the State Board of Education will be there to work with them and everyone in the community to achieve quality education throughout the state.
