BE IT RESOLVED that the Colorado State Board of Education:

- 1. Promote student engagement in policy-making dialogue about education in the Colorado Public School System, including the following objectives --
 - Establish effective communications with the Colorado High School Activities Association and local student government bodies/councils;
 - Investigate the creation of an electronic forum within the CDE web site to allow for informal exchange and discussion of information between students. Board members, and CDE staff:

- Investigate the creation of databank of best practices concerning student engagement; and
- Charge CDE Regional Service Teams with addressing student engagement issues at the regional, BOCES, and local levels.
- 2. Encourage all educational stakeholders statewide associations, BOCES, local district Boards to review their policies and to make the changes necessary to facilitate student participation and to provide regular opportunities for effective student input at conferences and meetings;
- 3. Recognize the importance of and continue to solicit student input on the goals, implementation, and progress of standards-based education in the Colorado public schools through visits to local districts, schools, and communities, and attendance at local and statewide student activities; and
- 4. Designate one week each year as Student Engagement Week in Colorado schools.
