# A YEAR OF MATH, By Jo O'Brien, Learning & Results Unit, CDE

The preliminary report just issued, entitled *The State's Prime Numbers*, examines the successes and challenges for the K-12 math instruction in Colorado schools. A colorful printing of this paper is now available for distribution. In tandem with this report, the annual summer Standards and Assessment conference will be focused on Mathematics. This "Math Summit" on June 7<sup>th</sup>, in Keystone, will illustrate the status of student achievement in math over the course of several years.

The findings of a year- long review indicate the lessons and topics that help schools close this math gap. It includes such facts as the large number of teachers in Colorado unaware of the math standards and the value of prerequisites such as arithmetic, conceptual understanding, reasoning and problem solving. The report includes average math teacher salaries, teacher math standard requirements and enriched roles which can be taken by CDE and other education support systems. Within the report are important cognitive research findings about math practice as well as specific math teaching research for students with math disabilities. The habits of Colorado "math successful" schools are featured, with an interesting and unexpected convergence of their behaviors and recommended math instruction research.

The summit will feature Colorado elementary, middle and high schools that have for several years successfully helped more students become math proficient. The keynote speaker will be Jim Stigler, internationally recognized

for the Third International Math and Science Study (TIMSS) and for his substantial achievement in video capture of great math teacher practice. He will share his critical findings through video clips, stories and math illustrations intended to exemplify the best of what we currently know. With instructional information and samples, more than 15 exemplar "math-successful" schools and a powerful and example- filled keynote address, CEA, CDE, CASE, and CASB expect a full house of participants this year. This subject-specific approach to the traditional standards and assessment conference will be repeated for all of our Colorado Model Content Standards. Next year, Science standards and performance will be reviewed and presented.
