I urge you and your BTOP team to support the application submitted by the Colorado State Library, in partnership with 76 Colorado public libraries and two Ute tribal libraries. The grant will impact a total service area of 2.5 million people with training and resources to underserved and unserved populations including those with low income, low education levels, low broadband penetration, and disabilities.

In my own path to achievement I utilized the public library in my community to gain knowledge that helped me excel. Through this grant, we would like to afford other Coloradans with the opportunity that access to the Internet and 21st Century resources can provide. With this grant, Colorado will be adding 692 laptops, 450 desktops, 68 ADA stations, 55 laptop carts, and other hardware and software to these public computer centers. These additional computers will reduce wait times in public libraries and allow the state and local agencies to provide training and support for those with highest need.

One goal of this grant program is to offer 10,000 classes over a two-year period in the various computer labs throughout the state. The State Library has developed partnerships to make this feasible including the Colorado Department of Labor Workforce Centers, Colorado Community College System, Colorado Adult Education and Family Literacy, Colorado GED Testing Centers, College in Colorado, National Libraries of Medicine, and the Colorado Department of Education English Language Acquisition Unit. Along with much-needed basic computer training, residents in these 76 communities will have training opportunities in workforce development, English as a second language, and resources such as GED and college preparation, consumer health, and other online learning and research tools.

At a local level, public and tribal libraries are collaborating with town and regional partners as witnessed by the 25+ partnership letters submitted from local agencies. Colorado is a locally strong state. Each community is planning for the most effective use of the public computer centers to meet the specific needs of each community. In Lamar, for example, the Future Business Leaders of America at the high

school intend to provide computer training classes for the public. In Red Feather Lakes, emergency services is needing these computers to access online training which would otherwise be unavailable to them in their remote location. In Cortez, the Sleeping Ute Mountain Chapter of D.A.R. is preparing genealogy classes.

For each of these 76 communities, local plans are beginning. Included in the application are 158 letters of support from city and county agencies, Chambers of Commerce, school districts, community colleges, and other local entities as a testament to the excitement and need for these Public Computer Centers in these diverse locations.

The Colorado State Library has a proven track record of implementing statewide initiatives in local libraries. In 2008, with an additional \$1,000,000 in state funds allocated for online databases, the State Library put together a package for local libraries that saw a 76% increase in the use of resources. This success is due to a strategic roll out which included statewide training and marketing support for local libraries and staff.

I strongly urge you to support the Colorado State Library's proposal for Public Computer Centers in Colorado. With BTOP Public Computer Centers, the needlest Coloradans will have the resources they need to improve their education and their lives. Thank you for your consideration. Please keep my office informed of any developments related to this proposal.

I am writing to support the application of the Colorado State Library for a second round American Recovery and Reinvestment Act of 2009 (ARRA) Broadband Technology Opportunity Program Public Computing Center grant. If funded, the State of Colorado will create or enhance seventy-eight public computer centers in Colorado, including seven in the First Congressional District, in low-income, diverse and underserved areas, including the state's Native American tribes. With this funding, nearly \$4 million will be used to expand computing capacity in libraries, schools and community centers through a series of fixed and mobile computer labs.

The project will use community outreach, library staff training, and development of state-wide, local and other partnerships to meet community needs. Current partners include, but are not limited to: The Bill and Melinda Gates Foundation, the Denver Public Library and more than seventy other libraries throughout the state, the Mountain Ute and Southern Ute Tribal Museum and tribes, College in Colorado, and, the Colorado Community College system.

The grant proposal focuses on four areas of need of interest to the citizens of Colorado: 1) increasing minority and rural access to education; 2) increasing education levels; 3) increasing income levels; and, 4) providing computing center access to disabled persons. This project, in addition to providing access to core programs, will provide sessions for high school students on college admissions, online college courses and financial aid resources. I am pleased to write this letter in support of the Colorado State Library's application for a Public Computing Center Grant in the second round of American Recovery and Reinvestment Act funding through the NTIA/BTOP program.

The proposed project, "Bridging Colorado's Great Digital Divide" will provide enhanced public computing access at public libraries in a total of 76 Colorado communities including the Denver Public Library, as well as at two Ute Indian Tribal Centers. The project will address the needs of Colorado residents living in areas with high rates of poverty and unemployment and limited access to free public computing facilities and free broadband Internet connectivity.

As individuals and families have faced the challenges of the economic downturn and increased unemployment, they have increasingly turned to public libraries. For many of these vulnerable individuals, their local public library is the only place that provides free computing and online resources. This access to computers and the Internet is essential for basic educational needs, computer skills training, job search skills, employment databases, and community, government and other online resources.

Just as people have faced hardships, communities have been similarly impacted by the economic situation. Cities around the country, including the City of Denver, are finding that decreased revenues make it impossible to provide additional funding to update and improve library public computing centers. The Colorado State Library's proposed project will provide the computers and equipment needed to enhance these computing centers in 78 Colorado communities.

The "Bridging Colorado's Great Digital Divide" proposal requests a total of 1,175 new computers to be distributed among the 78 Colorado locations. The Denver Public Library would receive 257 of these computers to be used at the Central Library and at six of DPL's branches located in neighborhoods with high levels of poverty, unemployment, minority populations and non-English speakers. These new computers will enable DPL to provide

well-equipped computer labs and training facilities for Denver residents having a great need for and limited free access to computers and the Internet.

The Colorado State Library's proposed project will also provide training and education services that will help meet Denver's and Colorado's greatest challenges, including: training in basic computer skills and essential software applications, workforce development, adult education, access to college education, English language learning and access to consumer health and financial information.

The proposal includes a strategic plan of community outreach, library staff development, and implementation of a statewide network of local partnerships to leverage resources and provide ongoing sustainability for the project. Also included is a marketing campaign geared toward the targeted populations, stressing the vital importance of developing the technology skills essential to 21st Century success.

Colorado State Library's staff has a strong record of managing grants and assisting local libraries in meeting the needs of Colorado communities. They will bring this expertise to the successful implementation of the proposed Public Computing Center project.

Thank you for your consideration of this application. I strongly endorse funding of this project on behalf of the residents of the City of Denver and the State of Colorado.



All of Montezuma County has been designated as an Enterprise Zone, recognizing the dismal economic status of the area. Almost all businesses are small mom and pop operations with only a small number of employees. For the most part, they do not offer medical insurance, retirement funds, etc. The graduation rate from Montezuma-Cortez High School is less that 60%.

The Cortez Area Chamber of Commerce working in partnership with the Small Business Development Center at Fort Lewis College in Durango, works with a large percentage of business owners who have little or no formal business training. We attempt to offer classes every other month in a variety of subjects. Unfortunately, what we can offer is limited by the fact that we don't have a computer lab. With this grant we would be able to offer classes in web site design, QuickBooks, and selling via the internet, as well as accessing professors at Fort Lewis who work to help us increase the success of local businesses.

When we set up a new agritourism program a year ago, we stressed the need for all agricultural businesses to have a website to participate. No one had one. This program would have allowed us to set up a workshop to get everyone up and running immediately.

As it is, the Cortez Library's computers are used extensively. Limited numbers of computers limits the time an individual can spend on line, and people wait for access. I can also see an opportunity for community members to access education on line to build their job skills. Many residents do not have the luxury of their own computer and their own access to the net.



I am President of the Paonia Chamber of Commerce, and am writing in support of the Colorado State Library's Public Computing Center application for the Broadband Technology Opportunities Program.

The Paonia Chamber is dedicated to the improvement of the Paonia area's economic and social health. This community faces a major challenge over the next half decade to decade. We have depended for a century or more on coal mining to sustain this community. We currently have approximately 900 coal mining jobs.

However, the mines are approaching the technological limits of their ability to mine coal in this valley. To be precise, the Oxbow Mine, with over 300 well paid employees (compensation of \$97,500/year), states that it will mine the last of its coal in December 2016. The other two coal mines will mine out their mineable reserves within a few years of that. The problem is that with current mining technology, the miners cannot work under more than 2,500 feet of overburden, and all three of our mines are approaching that limit.

One of the goals of the Paonia Chamber of Commerce is to prepare our community for the coming difficult transition. Paonia has "always" been a coal mining town. It supplies 1.5 percent of America's lowest sulfur coal. That coal is shipped not just to the East Coast, but to Asia as well.

The transition away from coal mining will be wrenching. Fortunately, we have some time to prepare for this transition. Also fortunately, this community has other resources: its agriculture, its physical beauty, its proximity to national forests and wilderness, and its diverse and multi-talented residents.

The Paonia Public Library will play an important role in this transition by providing information on possibilities for the future, by providing a wonderful meeting place for various groups, and by providing the computing power people and institutions here will need as we prepare for a very different economic future.

The Paonia Public Library has always been a center of the community. Now, more than ever, it will need to have the most up to date information gathering ability to help Paonia weather the coming difficult transition.

I am writing to express my support of the Colorado State Library's application requesting funding for "Bridging Colorado's Great Digital Divide."

This proposed project will provide the computer equipment and training needed for 78 public computing centers located at libraries in 76 Colorado communities (including the Denver Public Library) and on two Ute Indian reservations. The project is designed to meet the needs of underserved residents of communities experiencing increased rates of unemployment and poverty. For these individuals and families, the local public library often provides their only free access to computers and the Internet. The proposed project will provide the additional computers and equipment needed to ensure this access.

As Denver and Colorado residents are experiencing economic challenges, they are using public libraries more than ever. They count on their local library for computer use and Internet access. They rely on library staff for training in computer and software use, job search skills, resume preparation and online job applications, as well as for educational needs.

At a time when libraries are striving to meet these needs for increased services, local governments, including the City of Denver, are finding that decreased revenues make it impossible to provide additional funding to update and improve the libraries' public computing centers. The Colorado State Library's proposed project will provide

the computers and equipment needed to enhance these computing centers in 78 Colorado communities.

In 2007 Denver voters approved the Better Denver Bond Program that included funds for renovation and refurbishment of existing Denver Public Library facilities. These funds are being used to create a large new Community Technology Center (CTC) at the Central Library and improvements and upgrades at the six Denver branch libraries named in the "Bridging Colorado's Great Digital Divide" project. While bond funds are paying for the building renovations, these funds cannot be used to purchase new computers. Work on the Central Library's Technology Center is nearly complete. Most of the Central Library's current public access computers will be moved to the CTC, however, this will leave the new 37-station computer training classroom and a wired community space designed for 55 workstations without computers. Similar situations exist at the six branch libraries. The new computers to be provided by the Colorado State Library project would enable DPL to serve the people of Denver with well-equipped facilities and greatly needed programs.

In addition to purchasing computers, "Bridging Colorado's Great Digital Divide" will provide training and education services to maximize the value of the computing centers. The proposal provides a strategic plan for community outreach and library staff development. It also addresses the development and implementation of a statewide network of local partnerships to leverage resources and provide project sustainability.

Over the years, the Colorado State Library has established a record of effectively managing grants and assisting libraries in meeting the needs of their communities. The CSL staff will use their knowledge and experience to successfully implement "Bridging Colorado's Great Digital Divide." I strongly urge funding of this vital project.

I am the principal at 7th Street Elementary School in Dove Creek organization, I am writing in support of the Colorado State Library' Public Computing Center application for the Broadband Technology Opportunities Program. It is beneficial that our small rural area has stable internet access and computing capabilities for our community members, students and staff.

Dove Creek is a small rural community located in Southwestern Colorado. It is approximately 35 miles to Cortez which is the nearest town which would have any substantial services. Dove Creek is located in Dolores County, which is consistently ranked at the top of the list in unemployment rates and families receiving some form of assistance. Currently, over 50% of our students qualify for free or reduced lunch, but this number is low, because there are many families that refuse to full out the required paperwork. The other problem with this area is there are no major employers to provide jobs, most jobs are minimum wage service jobs.

Our achievement data indicates that we are making progress with our students. However, the rate of growth is low and there are many technology applications including internet based programs that we can access to improve our overall academic programming. We currently offer internet college credit classes; it is over 100 miles to the nearest higher education campus.

I feel we will increase our college offering to students and community members as our technology capabilities increase. Technology has to be accessible and easy to use in order for people to utilize it. This funding will increase our access and technology capabilities. Hopefully, we can seek out a variety of post-secondary colleges to partner with.

We are in a unique situation due to the fact that we currently have a partnership between the Dolores County Library system and our school district. All libraries are housed in our schools, which provide access not only to our community, but students and a staff. I do not have budgetary control, but would highly encourage our district to provide whatever financial support needed to receive this funding.

The Dolores County Commissioners would like to express their support of the Dolores County Public Library & Distance Learning Program application for the Broadband Technology Opportunities Program. The Commissioners are very excited about the benefits such a program would bring to our community, including increased access to vital technology and increased learning opportunities.

Dolores County faces significant barriers to widespread computer access. First, our County has the highest unemployment rate in the state at 17%, and a large percentage of our families live at or below the poverty line. Computer access and training are not high priorities for these households. Next, we are located in a very rural area and lack widespread internet availability. Due to the rural nature of Dolores County, there is a significant distance factor involved which impedes using other publicly available resources outside of Dolores County. Finally, while recognizing the importance of widespread computer access in job training and achieving educational parity, Dolores County lacks the funds to implement such a program. Therefore, the Broadband Technology Opportunities Program would be of enormous help to Dolores County.

The Dolores County Public Library & Distance Learning Program is a vital resource for Dolores County. This equipment will allow students access to additional learning resources as well as provide opportunity for adult education.

Dolores County ranks as one of the poorest counties in the State as well as ranking high in unemployment. There are no major industries in Dove Creek and patient statistics from the Community Health Clinic show 65 percent of patients have incomes 200% or below Federal Poverty Level.

I am the District Library Media Coordinator for Brush Public Schools RE-2J. On behalf of my organization, I am writing in support of the Colorado State Library's Public Computing Center application for the Broadband Technology Opportunities Program. I am particularly excited about the benefits of having the capability of accessing employment opportunities and training opportunities that enhanced computing and Internet access at the East Morgan County Library will bring to our community.

As a rural, agriculturally based community, our community is often behind other communities in terms of technology. We have only a few employers who hire large numbers of people, with the majority of people working either for themselves or for small businesses. The economics of the past two years have not helped. Many community members are forced to look for work elsewhere and this hurts the community. Purchases of computers are often outside the reach of many of our families, particularly our large Hispanic population, who use the public library as their means of connecting to the rest of the world. Many of our families have cut internet access to their homes due to cost. I see this daily at the schools I work in. We have more and more students staying after school to use the computers than ever before.

Our organization is here to educate future citizens. We are currently connected to the Internet on all school computers, but we lack staffing to open the computer labs to the public. Our public library helps us out currently by staffing a lab one night a week, but that will end at the end of this month when their facility reopens. Due to filtering issues that schools face, the public is reluctant to use our computers and turns to the public library instead. Increased access there will be a tremendous boon to our community being able to access the world-wide-web.

Having this increased access at the public library will make it possible for more people to look for employment outside of our region. Additionally, with the increase of on-line classes, more of our community will be able to access those educational opportunities. Disabled members of the community will be able to use these computers with the help of ADA Compliant work stations, giving them access they themselves cannot afford. This will be of help to many of our students as well as they often do not have the technology they need at home.

Our school and public libraries have always had a good working relationship. Together we strive to meet the needs of our students both at school and at home. The increase in technology at the public library will give me the opportunity to encourage students to use

the public library in their off school time to meet their academic needs. I currently just have to send students home when it is time for staff to go home. The few computers at the public library are in almost constant use and that makes it difficult for students to complete assignments. Increased access at the public library will help my students who need that access. We plan to place ads in the monthly newsletters about the public library's increased access and encourage parents to take their students there to complete assignments. While we cannot help with financing, we can send patrons their way.

I am the Executive Director of the Colorado East Community Action Agency. On behalf of my organization, I am writing in support of the Colorado State Library's Public Computing Center application for the Broadband Technology Opportunities Program. I am particularly excited about the benefits, such as the increased ability to service rural clients, that enhanced computing and Internet access at the Simla Branch Library will bring to our community.

As an agency that serves low income, elderly and handicapped citizens in the four rural Colorado counties of Cheyenne, Elbert, Kit Carson and Lincoln it is a challenge for our staff to be able to supply services to geographically remote locations. These rural residents do not have ready access to free income tax preparation and Medicare counseling. Often these residents are in need of advocacy when in need of various services. While we have an Outreach Worker in Elbert County, the need for her services is often beyond what one counselor can provide. We are increasingly developing ways we can improve service delivery via technology.

Our current services include free income tax preparation as well as Medicare insurance counseling. We also provide linkages to other available services, federal, state, local or private.

The Simla Library already does an excellent job of attracting community members and providing a centralized location for community needs. In our own case, for the past two years the Simla Library has allowed us to use their facilities to provide free income tax preparation for low income residents. The support the library staff

has given us has allowed us to come into the community and offer this valuable service in a convenient location

Enhanced computer access has the potential of allowing us to further expand our services to the community. We could provide more tax help as well as ongoing Medicare counseling. Better computer capabilities would enable us to serve more people more frequently with few staff hours.

With better computer technology we would be able to increase the amount of services we provide to the residents in and around Simla. We would also be willing to work with the Library to increase any services to the target population. We would be open to collaborating on any needed training and would be willing to share any appropriate statistics as requested.

I am a local wildlife officer for the Colorado Division of Wildlife (CDOW). My district includes Elbert and El Paso counties. I am writing to express my support for the Elbert County Public Library in applying for the Colorado State Library's Public Computing Center for the Broadband Technology Opportunities Program. I am particularly excited about the benefits it will bring to our community such as enhanced computing and Internet access at the Elbert County Public Library.

Many people who contact CDOW often get directed to the CDOW website to retrieve information relating to wildlife viewing, living with wildlife, hunting and fishing information. Often times, when a person requests information, they like to receive that information as quickly as possible. The information that one had to wait to be received in the mail can now be accessed quickly and easily from the internet. Home internet may not be an option in rural communities because of the cost for satellite service when DSL or cable internet service is unavailable.

The CDOW encourages outdoor enthusiast such as hunters, fishermen, and wildlife watchers to prepare and plan ahead for a trip. Most of the information can be found on the internet, however a significant amount of the information is also found at local libraries. Being able to access both resources at one location will make the planning part of a trip more efficient and enjoyable. CDOW also utilizes websites for online Hunter Education. Hunter Education is a required course one must complete before they can hunt. Hunter Education is not only for those who wish to hunt, but also teaches safe firearm handling. Many Hunter Education instructors have discovered that kids have increased test scores when they take the class online compared to a traditional class setting. This is often because the internet can be used to teach people based on their different learning styles and at one's own pace. Online hunter education courses utilize video, text, interactive demonstrations, and opportunities for text to be read to the student. Once a student completes the online portion, they attend a class where they take a test and have hands on training.

CDOW has experienced and recognizes a decrease in wildlife recreation over the past several years. CDOW relies on license sales as the primary funding source for wildlife management and habitat protection, and is not funded by state tax payers. Rural communities also benefit from wildlife recreation and activity. Often hunters, fishermen and wildlife viewers stay in small town hotels and support local businesses. In attempt to reduce the decline that affects both CDOW and rural communities, CDOW is taking innovative approaches to advertize and market wildlife recreation. Most of the marketing and resources are driven by the internet.

I am a City Councilman for the town of Fleming, Colorado. On behalf of the Council, I am writing in support of the Colorado State Library's Public Computing Center application for the Broadband Technology Opportunity Program. I am particularly excited about benefits such as increased public access to the world that enhanced computing and Internet access at the Fleming Community Library will bring to our community.

Fleming, a town of 400 citizens and community center for another 200 doesn't have a doctor or hospital, but makes do with the nurse practitioner. The nearest hospital and clinic utilize a medical service provider which provides "the doctor of the week" resulting in the need for patients to be highly informed about their family's and their own health and medications. Our students are falling behind in acquisition of 21st-century skills because our hardware and Internet facilities are outdated. The primary objective of Fleming Schools is to educate tomorrow's citizens, a lofty goal crippled by last decade's-old technology. Because Fleming is a tiny remote rural community, access to a university library or another in-depth research facility is difficult. Our population demographic is a reverse bell curve with aging grandparents caring for young children while working adults live wherever they find paying jobs. The commuter adults try to work on skill upgrade, while here over weekends and are hampered by the technology available in the library. The only large employers in the area are the Colorado Department of Corrections (DOC) and local agricultural cooperatives. The DOC is undergoing budget cuts in local cooperatives are automating. Residential property values have remained relatively steady, but low. The combination of few jobs, fewer well-paying jobs, and low tax revenues have limited the ability of the Fleming Library to meet patron needs.


The goal of Fleming Community Library is to facilitate the learning, training, and enjoyment of student and adult town residents and those in the surrounding community. The library is wheelchair accessible and allows patrons easy access to all areas of the library, including computer stations. The library acts as a community education center, and all library patrons may access Internet information and library materials for their personal and professional growth. Because of its location and isolation, Fleming does not receive daily delivery of newspapers from any metropolitan center. These newspapers must be accessed via the Internet for those wishing access to the news and any job or retail information from

outside the Fleming area. Many goods and services are not available locally, and residents must research and diagnose their needs, determine the procedures and products necessary to meet those needs and make the orders themselves over the Internet. Many library patrons do without because they don't have adequate technology at home and the technology at the library is outdated and our library staff has limited training in assisting patrons with technology.

There are no training facilities, easily accessible to community members without extensive travel. Access to training by Internet is the only viable training opportunity available to numerous library patrons. Applications for many jobs are accessible only online and access to them will allow Fleming, community members better opportunities to seek employment in a difficult economic environment. New and upgraded computers and Internet access will allow those seeking 21st-century skills the opportunity to fulfill their needs in our global economy. Library patrons will have access to the latest in government information and will be able to find out what is happening at the city, county, state and national level. Important information concerning the workings, processes, programs, and procedures of government are often unknown to community members due to the lack of printed resources that reach our community. New computing power and Internet access will allow citizens to find information that is of vital import or interest to them.

I am the Veterans Representative/Employment Specialist at the Fort Morgan Workforce Center. On behalf of my organization, I am writing in support of the Colorado State Library's Public Computing Center application for the Broadband Technology Opportunities Program. I am particularly excited about the benefits, such as additional computer access for job seekers in the community, that enhanced computing and Internet access at the Fort Morgan Public Library will bring to our community.

The customers of the Workforce Center encompass a broad section of the area community and include people from all levels of education and economic status. Since all persons on Unemployment Insurance must be registered with the Workforce Center, and the unemployment rate has been much higher for the past eighteen months, we have seen a sharp increase in folks in very dire economic circumstances. There are far more people seeking self-sufficient entry level jobs in the area then there are job openings.

The primary objective for the Workforce Center regarding job seekers is to either directly provide them with the tools to find a job, or refer them to agencies that can further that goal. Internet access is very important to this population. Many jobs can only be applied for online, and with out internet access the job seeker does not have the opportunity for those positions. We do have a resource room, but we only have four computers with internet access. It is common that we have to ask people to wait because all of the computers are busy. Additional internet access would be a great help to the job seekers. The location of the Library is directly across the street from the Workforce Center, making it an ideal location for our customers.

The Workforce Center has partnered with the Fort Morgan Public Library in the past by utilizing the current computer lab for computer job search workshops. The additional computers would be a great help to us in expanding those workshops to job seekers. The numbers of people that have very limited computer skills but are looking for jobs that require some computer background is a constant challenge for us. A resource like the additional computer access at the library would be a very valuable tool for the marketing of the computer workshops. The hours of the library could accommodate people who work during the day. The Workforce Center could track those attending the workshops and also collect surveys to better focus the topics of the classes.



I am the Coordinator for two programs at the Gunnison County Department of Health and Human Services; The Foster Care Program and The Early Childhood Council. On behalf of my organization, I am writing in support of the Colorado State Library's Public Computing Center application for the Broadband Technology Opportunities Program. I understand the importance of providing quality Internet access to our community. It is a valuable and integral part of the lives of community members that helps them succeed in their professional and personal lives. Enhanced computing and Internet access at the Gunnison County Public Library will bring increased access to services in our community. It is highly important to bring enhanced computer and Internet services to Gunnison County Public Library for the following reasons:

One of Gunnison County's largest populations in need of increased computing and Internet access is the large migrant and immigrant populations. Many individuals come to the Gunnison Valley to seek employment from the ski and tourism industry. This population is at risk because they are disenfranchised by poverty, lack of social network, lack of knowledge of services and resources in this community, and above all-language barriers. Access to Internet and computers would provide them with valuable information about health and other resources in our community, as well as allowing them to search for information in their language. As our world becomes increasingly more computerized, many job applications are only accepted by electronic submission, thus forcing one to use a computer. For Gunnison's migrant and immigrant populations, one of the only points of access to a computer is the Gunnison County Library.

My program, the Early Childhood Council, partners with the Gunnison County Multi Cultural Resource Office. For this reason, I am aware of this need. It would greatly serve one of Gunnison's most venerable populations, and increase the probability that this at risk group would achieve employment, communication, increase their knowledge of health, and available services, if the Gunnison County Library is awarded funding for enhanced computing and Internet access.

Not only would enhanced computing and Internet access serve Gunnison County's migrant and immigrant populations, but there are many other community members who would greatly benefit from this service. As Coordinator for the Early Childhood Council, I am an advocate and supporter of the importance of high quality early childhood care and services for young children. Providing quality early childhood settings is one of the most important ways that we can strengthen our community. According to the Bell

Policy Institute, for every dollar invested in early childhood, seven dollars is returned in the long run.

The Early Childhood Council has a web site with information for parents about local licensed child care providers, education about the importance of quality early childhood care, and many other resources for parents. Information for Family Home Care Providers as well as Child Care Centers is also accessible on our web site. As many Family Home Care Providers do not have access to Internet in their homes, and are not computer literate, the library is an important resource for these professionals to obtain information about training, rules and regulations governing child care homes, and help them to grow their businesses through internet and email marketing.

I envision the library with enhanced computing capability as a community destination.
