3) Update on "I'm an Online Learner" WebJunction Classes

- a) 300 units purchased, available since October
- **b)** Sold 88 units so far (66 to public, 3 to CSL, 1 to CLiC, and 20 to institutional libraries)
- c) Need to pay more attention to completion statistics
 - i) Only 46 units have been used
 - ii) Only 5 have completed course
 - iii) Uncertain if these statistics are reliable
- d) Feedback about the classes has not been positive so far
 - i) May not be course content; could be the non-personal experience of online learning
- e) Some libraries who bought blocks of units want to test them out before advertising to others
- f) Some courses are just PPTs that the user would click through, but not all.
- g) Need to identify which topics are of interest to library community
 - i) Test out courses related to that topic to see if they are of good quality
 - **ii)** Go beyond the course material, like using a wiki to discuss which courses are good, etc.
- h) Sharon will survey other states to see which ones have been most useful
