Section B: Student Alternative Pathway to a Diploma:				
Per Weld RE-4 School Board approval August 2010, any student with a current IEP may use ACE/OJE as a core replacement if documented on the IEP as aligning with the student's postsecondary IEP goals and with approval from the school Principal and Director of Exceptional Student Services (up to 4 blocks per week). Students may use the IEP process to identify appropriate course alternatives to those established by the Weld RE-4 School Board Policy IFK to better pursue readiness for their postsecondary goals and to obtain a regular high school diploma.

I understand that this agreement entitles me/my child to earn a high school diploma through an alternative pathway at Windsor High School. I understand the following:				
<ol> <li>By choosing this route, any graduation course requirement may be supplanted by an alternative course option with the following provisions:         <ul> <li>a) The course alternative CLEARLY better prepares the student to achieve their stated IEP postsecondary goals</li> <li>b) The course alternative is agreed upon by the IEP team</li> <li>c) The course alternative is approved by the Windsor High School Principal</li> <li>d) The course alternative is approved by the Director of Exceptional Student Services</li> </ul> </li> </ol>				
2. If a core academic credit (not an elective) is supplanted for this purpose, the student must also pass the Work Keys assessment with a minimum of a Silver Level of achievement in all measured areas (Reading, Math, Locating Information)				
3. Students must still attain 28 total credits as outlined by Weld RE-4 School Board Policy IFK but may use the Work Keys assessment as verification of readiness for exit and postsecondary success 4. Students in this pathway MUST enroll in ACE and may opt to use OJT or OJE as a means to attain credits
