Jane Goff Will Be Sworn In Wednesday, March 5; Board Meeting Agendas for March 5, 6

Newly appointed State Board of Education member Jane Goff will be sworn in Wednesday, March 5 at 7:45 a.m. prior to the March monthly work session, beginning at 9 a.m. The event will be held in the lobby at the Colorado State Board of Education offices, 201 E. Colfax Ave. The public is welcome.

Goff was appointed by the Democratic vacancy committee in February to fill the remaining term of Karen Middleton, who resigned to take an open seat with the State House of Representatives. Goff will represent the 7th Congressional District and would stand for re-election, if she chooses, in November 2008.

Goff recently retired from a 34-year career with Jefferson County Schools. She taught middle school and high school French and Spanish until 2003, when she was appointed as the district's coordinator of world languages and international student exchange. She supervised the district's world language curriculum, directed the first-year language teachers' induction program, and approved the admission of foreign exchange students to Jefferson County high schools.
