The Colorado State Board of Education is expected to adopt new Colorado Academic Standards by December 2009 following a nearly two-year conversation involving 13 model content standards— civics; dance; economics; geography; health and physical education; history; math; music; reading, writing and communicating; science; theatre; visual art and world languages; and English language development standards.

In 2007 the state board recommended a comprehensive revision to the Colorado Model Content Standards. Senate Bill 08-212 (also known as CAP4K—the Colorado Achievement Plan for Kids) affirmed revisions and expanded outcomes should include a seamless pathway from preschool into postsecondary education or the workforce.

Colorado is also required to adopt a revised system of assessments that aligns with the updated state content standards. An assessment stakeholder committee met for the first time on Monday, Oct. 26 to explore options for the new assessment system.
