State Board Meeting Agenda for Wednesday, Nov. 11 Includes Review of Revised Content Standards; Regular Meeting Thursday, Nov. 12

The Colorado State Board of Education this week will hold a work session on Wednesday, Nov. 11 and its regular monthly meeting on Thursday, Nov. 12.

The meetings will begin each day at 9 a.m. in the first-floor board room at the Colorado Department of Education offices, 201 E. Colfax Ave. in Denver.

The work session on Wednesday will include the board's review of draft model content standards in all 13 model content areas. The 13 content areas are civics; dance; economics; geography; health and physical education; history; math; music; reading, writing and communicating; science; theatre; visual art and world languages, and English language development standards. The board is scheduled to consider adoption of the new Content Academic Standards in December.
