***Town Hall Meeting in Limon Feb. 4 Continues Next Phase
Of CAP4K And Assessment Revision Effort***

The Colorado Department of Education and the Colorado Department of Higher Education will jointly host a town hall meeting in Limon on Thursday, Feb. 4, as part of the ongoing effort to redesign the state assessment system.

The meeting in Limon will be held from 5 to 7 p.m. at Morgan Community College – Limon Center, 477 D Ave., in the Community Building.

Educators, students, parents, business and community members and interested citizens are invited to the meeting.

The statewide meetings solicit a broad spectrum of community thinking. The work was launched by Senate Bill 08-212, the "Preschool to Postsecondary Education Alignment Act," also known as the Colorado Achievement Plan for Kids (CAP4K).

To accommodate in-depth conversation on each end of the system, the 2009 – 2010 tour is split into two parts: one devoted to school readiness and

assessments for primary grades; and one devoted to postsecondary and workforce readiness and assessments for secondary grades.

The postsecondary and workforce readiness and secondary assessment meetings will take place from 5 to 7 p.m., the dates and locations are:

- Tuesday, Feb. 16 in Grand Junction, location TBD
- Wednesday, Feb. 17 in Gunnison, location TBD
- Wednesday, Feb. 24 in Alamosa, location TBD
- Thursday, March 4 in Pueblo, location TBD
- Wednesday, March 31 in Greeley, location TBD

The other set of meetings will emphasize school readiness and primary (P-6) level assessments. They will also be held from 5 to 7 p.m. at these locations:

- Thursday, Feb. 4 in Limon, Morgan Community College- Limon Center, 477 D Avenue, Limon, CO, 80828
- Tuesday, Feb. 23 in Cortez, location TBD
- Wednesday, March 17 in Steamboat Springs, location TBD
- Wednesday, March 24 in Glenwood Springs, location TBD

Senate Bill 212 was enacted in 2008. Last year the Colorado State Board of Education adopted descriptions of what it means to be both school ready and postsecondary and workforce ready. In addition, the new Colorado Academic Standards were adopted on December 10, 2009.

Under CAP4K, Colorado is required to adopt a revised system of assessments that aligns with the updated state content standards. The revised system must include both school readiness and postsecondary and workforce readiness assessments; summative assessment; and the assessments for special populations (English Language Learners and students on an Individualized Education Plan).
